



## Causeway Coast & Glens Borough Council Landfill

### Communities Fund 2025-26

Landfill Communities Fund will be a rolling fund and will remain open throughout the year until the budget is expended, at which point the fund will close for applications.

There will be assessment points throughout the year, contact The Central Funding Unit for advice on when the next assessments will take place. This will help you plan your project to ensure that grant-aid is awarded in time.

**Due to the closure of one of Council's landfill Sites, the Landfill Community Fund Grant Programme will be closing for applications. All projects successful in obtaining grant aid must have all works completed and claim submitted to Council no later than 31<sup>st</sup> December 2025.**

### Application Guidelines

Please read these guidelines to find out more about the Causeway Coast & Glens Borough Council Landfill Communities Fund Programme and the type of projects that are eligible.

The Landfill Communities Fund Programme is a partnership between Causeway Coast and Glens Borough Council and Ulster Wildlife Trust (Ulster Wildlife).

This document will help to guide you through the application process.

Applications can be made under any one of the following three themes:

- I. **Public Amenities (Natural and Social Environment)**
- II. **Biodiversity Conservation and Enhancement (Natural Environment)**
- III. **Restoration (Built Environment)**

Full details of these programmes and assessment/scoring criteria are available from the individual programme sheets annexed to these Guidelines.

## **1. Introduction & Background**

Funding for these programmes is available through the Landfill Communities Fund (LCF) which is regulated by ENTRUST ([www.entrust.org.uk](http://www.entrust.org.uk)) on behalf of Her Majesty’s Revenue & Customs (HMRC). It is ENTRUST’s role to ensure that LCF monies are paid to eligible organisations and spent on projects which satisfy the objectives (Objects) set out in the Landfill Tax Regulations 1996 as amended (the Regulations).

The LCF is a tax credit scheme that permits Landfill Operators to divert a percentage of the monies they pay as landfill tax directly to the approved organisations called Environmental Bodies (EBs) to fund community and environmental projects in the vicinity of landfill sites.

Causeway Coast and Glens Borough Council is a Landfill Operator and works in partnership with Ulster Wildlife, an EB, by contributing to the LCF to support projects that create benefits for communities living near landfill sites.

All projects funded by the LCF must be registered with ENTRUST and projects will need to satisfy the registration requirements of ENTRUST. Ulster Wildlife is authorised to submit projects for registration to ensure projects comply with the Regulations and their LCF activity is subject to regular audit by ENTRUST.

## **2. Who Can Apply**

Causeway Coast and Glens Borough Council has agreed that projects must be located within a ten-mile radius (as the crow flies) of the following landfill sites:

- **Craigahullier Quarry, 45 Craigahullier Road, Portrush BT56 8NN**
- **Craigmore Landfill Site, Craigmore Road, Garvagh, BT51 5HF**

The Council will not accept applications outside this area.

To be eligible for grant-aid, your organisation must be a well-run bona fide organisation with a properly adopted “Governing Document” such as a constitution or memorandum and articles of association that clearly show that it is non-profit making and taking. Evidence that a constitution has been formally adopted must be supplied.

No retrospective funding can be claimed under the LCF. Projects that have already started are therefore not eligible to apply.

**All successful projects must be able to demonstrate that their project can complete all associated works, submit a claim with all associated documents to Council no later than the 31<sup>st</sup> December 2025.**

### 3. Grant Amounts

A grant of 75% of total project costs to a maximum of £15,000 and a minimum of £5,000 will be available to individual projects. Applicants are required to provide details of match funding secured which for community-led projects can include “in-kind” contributions.

Grants can not be claimed for unpaid costs. Projects must therefore make arrangements to enable payment to suppliers to be made prior to claims for reimbursement. The process for grant claims will be made available to successful applicants but at this stage projects should note that evidence of value for money will need to accompany claims.

Recoverable VAT (if any) will not be refunded.

### 4. How to Apply / Application Process

#### Stage 1

**Applicants can apply to one of the following three Programmes:**

*(All projects must demonstrate how they provide protection for the built, natural or social environment).*

- I. **Public Amenity Programme** applications must satisfy the requirements of LCF **Object D** – Public Parks and Amenities. The focus must be to undertake direct physical works on a park/amenity which must be open to the general public a minimum of four evenings or two days a week or 104 days a year.
- II. **Biodiversity Conservation and Enhancement Programme** applications must satisfy the requirements of LCF **Object DA** - Conservation of Biodiversity. Project costs must relate solely to the conservation of the species or habitat and the works must be carried out on a site where the species or habitat naturally occurs.
- III. **Restoration Programme applications** must satisfy the requirements of LCF **Object E** – Restoration of Religious Buildings or Buildings of Architectural or Historical Interest. The intention should be to maintain, repair or restore either a place of worship, or a building or structure with a listed status or equivalent, where the general public have access. This object does not permit new works or works to private residences.

**All successful projects must include an immediate start date and have works completed and claim submitted by 31<sup>st</sup> December 2025.**

## **Stage 2**

Applications will be assessed for:

- eligibility by the Council's Central Funding Unit,
- LCF eligibility by an Officer from Ulster Wildlife,

and then scored by Funding Unit Staff and an Officer from Ulster Wildlife.

## **Stage 3**

Projects will ranked based on score subject to achieving a minimum of 65% (as set out in the individual programme sheets) and presented to Causeway Coast and Glens Borough Council to approve allocation of funds. This allocation will be subject to satisfactory registration of projects with ENTRUST, the scheme regulator.

In the event of the fund being oversubscribed, two objective measures will be used for ranking applications:

- distance from Craigahullier Quarry or Craigmore Landfill Site; and
- level of match funding available.

## **Stage 4**

Applicants will be informed of the Council's decision after the assessment panel and Ulster Wildlife will then proceed to seek registration of projects with ENTRUST.

Successful applicants must deliver a signed hard copy of their Part B application form to Ulster Wildlife's offices at McClelland House, 10 Heron Road, Belfast BT3 9LE prior to the registration process commencing and may be required to provide additional information to complete registration.

Please note that successful registration of projects is essential to complete the approval/allocation process.

## **Stage 5**

Once projects have been successfully registered with ENTRUST, Ulster Wildlife will issue letters of offer to successful applicants.

## **Stage 6**

Successful applicants must return the letter of offer within 14 days. The project must commence and be completed by 31<sup>st</sup> December 2025.

## 5. Assessment and Scoring

### How we assess and score your application.

Every application will be assessed for:

- compliance with ENTRUST and Council requirements as set out in the individual programme sheets before progressing to full assessment and scoring.

- capability of the applicant to deliver the proposal; and
- contribution to the LCF theme under which submitted.

See the individual programme sheets for full details of Assessment and Scoring.

This is a competitive fund and awards will be made based on highest scoring projects. In the event of a tie break situation, two objective measures will be used for ranking applications:

- distance from Craighullier Quarry or Craigmore Landfill Site; and
- level of match funding available.

## 6. Late applications

It is the responsibility of each applicant to ensure that their application is submitted prior to the advertised time and date of closing. Applications received after the closing time/date will not be considered for funding. No exceptions will be made and there is no recourse to appeal. It is the responsibility of the applicant to ensure submission on time.

## 7. Claims Process and Procurement

ENTRUST require that where LCF monies are used to purchase goods and services over £5,000 in value, competitive tendering should be undertaken. Three quotes should be sought when the value is less than £5,000. Evidence of the competitive tender and quotes must accompany each claim.

Payments to suppliers must be made from the applicant's own resources and evidence of value for money demonstrated as required in the Environmental Body (EB) Guidance Manual available at [www.entrust.org.uk](http://www.entrust.org.uk).

Application for reimbursement must be made within the timescale set out in the letter of offer and Ulster Wildlife will advise projects of documentation required for grant claims. Applicants will be reimbursed by Ulster Wildlife once documentation has satisfactorily verified. **All claims must be submitted no later than 31<sup>st</sup> December 2025.**

## 8. Fraud and Corruption

Causeway Coast and Glens Borough Council is committed to carrying out business fairly, honestly and openly and has a zero tolerance towards fraud, bribery and corruption. Causeway Coast and

Glens Borough Council expects full compliance with the requirements of both the Fraud and Corruption Policy and Bribery Act 2010 from Groups or Individuals applying for, or in receipt of grant aid. Causeway Coast and Glens Borough Council reserves the right to disallow any other grant applications and claims submitted by a group or an individual member of a group in respect of the financial year and to apply a moratorium on Council funding to any group or individual member of a group where fraudulent activity has been identified within the current financial year and for at least two forthcoming financial years. This also applies to individuals applying or claiming for bursaries.

Causeway Coast and Glens Borough Council will inform the group's Chairperson where attempted or suspected fraud has been identified.
