Item 4. Minutes of Previous Meeting 16th November 2023 were approved as a

Item 5. Update

- The Action Plan was passed at November's Leisure & Development Meeting, proposed by Cllr Schenning and seconded by Cllr Anderson.
- In the interim period from 21st Nov until 13th Dec the Peace Co-ordinator has been working on getting the appendices ready and the Plan finalised, and it was submitted to SEUPB on 13th Dec.
- It is envisaged that the Letter of Offer will be made around 20th April with delivery possibly starting September 2024.
- Staff recruitment was discussed and due to inflated staff costs since 2016, recruitment of other staff is unlikely until Sept 2024 to allow for the costs of the programme running until March 2027. Peace co-ordinator advised that we could claim 15% towards office & admin costs and 7% towards mileage.

Discussion was held about the importance of having sufficient staff coverage for the programme to run effectively and the need to have a safety net in place for this to happen.

• Executive Office held a meeting on 3rd December. PeacePlus costs can be claimed from 15th December. SEUPB are aware of financial constraints within some councils.

Item 6. Next Steps

- The Communications sub-committee will meet in January to discuss how the plan will be presented and to give an update on the programme via social media and roadshows. Dates/time will be sent out for a possible meeting date.
- Info sessions could be run in the New year for prospective bidders with the possibility of starting to write up specs for tenders and provide them with an overview and expectations of the programmes and delivery.

Item 7. Updated PeacePlus Standing Orders Nov 23

- These were issued with the names of the new members and as information for all.
- Discussion was held with regards to the recording of future meetings. Peace Co-ordinator checked this with Democratic services and Policy informed that a Data Protection Impact Assessment needs to be completed (DPIA). The DPIA needs to go through corporate services. A survey will be sent out in January to all members to get feedback about this.
