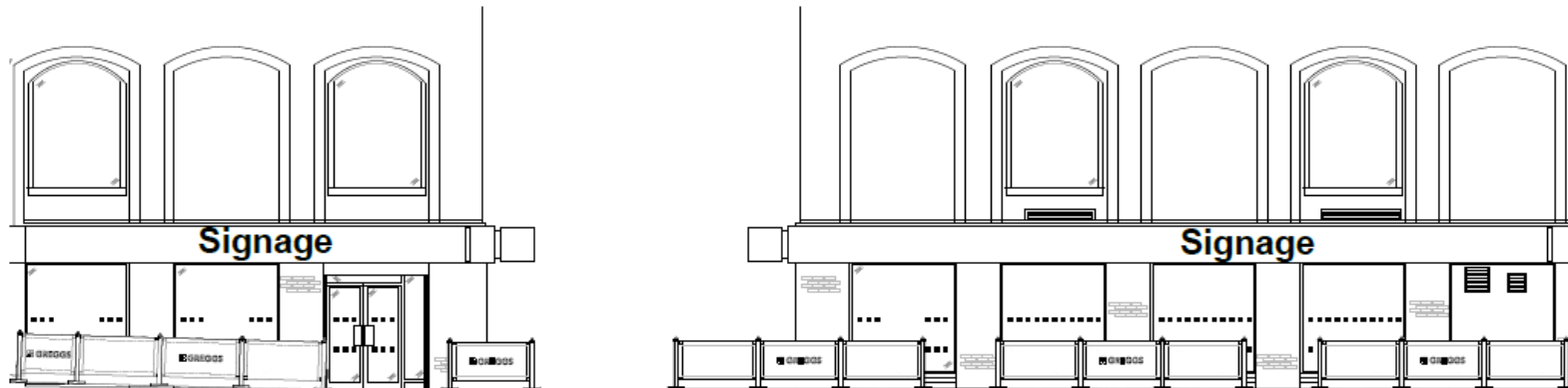
BARRIERS WILL BE PLACED AS DETAIL TO ADEQUATELY SCREENING / TO DEMARCAT THE LICENSED AREA AND CONTAIN THE TABLES AND CHAIRS, IN ORDER TO MAKE IT DISTINGUISHABLE TO OTHER PAVEMENT USERS, AND TO ASSIST BLIND AND VISUALLY IMPAIRED PEDESTRIANS.

PORTABLE, STURDY BARRIERS HAVE A TAP RAIL ARE RECOMMENDED.

BASES ARE WEIGHTED AND SMALL ENOUGH NOT TO CAUSE AN OBSTRUCTION OR TRIPPING HAZARD TO PEDESTRIANS. BARRIERS CAN BE BROKEN DOWN FOR TRANSPORT

SEATING AND TABLES CAN BE CARRIED AND ARE LIGHTWEIGHT IN CONSTRUCTION AND PORTABLE, BUT STABLE ENOUGH TO PREVENT COLLAPSE IF ACCIDENTALLY WALKED INTO OR OVERTURNED BY A SUDDEN GUST OF WIND.

THE SEATING, TABLES AND BARRIER COLOURS AND MATERIALS USED FOR THE ENCLOSURE MUST PROVIDE A CONTRAST WITH THE BACKGROUND TO TAKE ACCOUNT OF THE NEEDS OF THOSE WITH A VISUAL IMPAIRMENT
