1.0 Purpose of Report

“I call upon this council to submit an application to host Armed Forces Day 2026. This significant event is a great opportunity to show our support and give thanks to our military personnel and families both past and present including our veterans and cadets.

This event will attract thousands of visitors to our Beautiful Borough, supporting our local traders and tourism providers.”

3.0 Draft Armed Forces Day Programme

- 3.1 Officers are now working towards preparing a programme of activity. The initial Draft Armed Forces Day Programme is at Appendix A.
- 3.2 This Programme will be updated as and when activities have been agreed, similar to the previous event in 2018.

4.0 Financial Implications

- 4.1 A budget should be agreed in order to progress with activities associated with Armed Forces Day 2026.
- 4.2 Consideration has been given to the financial implications as part of the Estimates process for 2025-26, however it is anticipated that the majority of the spend will be incurred in the 2026/27 financial year.
