	In November 2023 the Department of Finance consulted on seven rates proposals: four in the non-domestic sector and three in the domestic sector. That consultation process was advertised in the local press and attracted a significant amount of coverage in local and national media, and social media; it launched on 7 November 2023 and the associated summary consultation report was published on 10 September 2024. A supplementary consultation has been launched this week that now builds on that prior process and the feedback provided to the Department. This supplementary consultation also forms part of the Finance Minister's work on the Strategic

The two domestic rating proposals being looked at by the Department in this supplementary consultation are:

- 1. Increasing the maximum capital value cap ("the cap" or "max cap") within the domestic rating system from £400,000 to £485,000
- 2. Reduction in the Early Payment Discount from 4% to 2%

4.	Department for Economy	Views on Changes to Electricity Reinforcement Connection Charges	24 April 2025

Consultation on the Department for Economy proposal that a higher proportion of the cost to reinforce new connections to the electricity grid will be spread across all customers and paid for over a longer period. This is known as 'socialisation of connection costs'.

Under the current system, adding a new low carbon connection such as a heat pump or EV charger may require reinforcement to the electricity grid. The cost of this initial reinforcement is currently charged to the householder or business requiring the upgrade. However, other electricity customers who share the line can potentially add a low carbon technology at a later time without having contributed to the initial cost of the upgrade. This is known as 'first mover disadvantage'.
