1.0 Purpose of Report

The purpose of this report is to recommend grant awards for the Christmas Festive Fund 2025-26.

2.0 Background

Causeway Coast and Glens Borough Council launched the Christmas Festive Fund in 2015 to offer assistance to Community and Voluntary Organisations from the smaller towns, villages and hamlets in the Borough to help celebrate Christmas. This fund is specifically designed to mark the lighting of the Christmas tree and help facilitate outdoor festive celebrations within the Borough.

In June 2023 the Council agreed to the new parameters of the fund, as follows:

Fund A - Settlements with a population of 1,000 and above can apply for up to £2,500 towards costs relating to festive entertainment. Priority will be given to projects that promote wide community involvement for **outdoor events**. (Fund A is for 13 principal settlements including Portstewart, Dungiven, Kilrea, Greysteel, Cloughmills, Castlerock, Cushendall, Garvagh, Dunloy, Rasharkin, Ballykelly, Bushmills, Portrush).

Fund B - Settlements with a population between 100 -1,000 can apply for up to £750 towards costs relating to festive entertainment. Priority will be given to projects that promote wide community involvement for **outdoor events**.

In 2024/2025, 30 projects were awarded funding totalling £42,362.

3.0 Overview of the Fund

The budget set for the Festive Fund per annum is £43,000.

Community groups and voluntary organisations can apply for grant-aid to allow small towns, hamlets and villages to celebrate Christmas by organising outdoor events and activities in their local communities:

- Applicant areas must have a population of over 100 residents or have been allocated a Christmas tree from Causeway Coast and Glens Borough Council.
- Projects/events should take place in the local community between Saturday 29th November and Thursday 18th December 2025.
- Activities must be cross community and open for all residents offering an opportunity for all within the locality to participate.
- Only one grant per settlement will be awarded. Should Council receive more than one
 application per settlement the application which is the most inclusive and has the most
 far-reaching community involvement will be selected. Council can also request that
 applicants work together to produce one all-inclusive event.

5.0 Outcome

27 applications were received by the closing date. The Funding Unit carried out the Stage 1 eligibility checks with all applications progressing for assessment and scoring against the agreed criteria – summary below:

No applications were received from 4 of the 13 identified towns eligible to apply for Fund A. Council officers continue to work in these 4 areas to facilitate applications to the fund.

6.0 Recommendation

It is recommended that the Leisure & Development Committee approves to full Council:

- 1. The allocation of grant-aid totalling £33,747 to projects numbered 1–27, as set out in **Annex A.**
- **2.** The Festive Fund remain open to facilitate applications from the 4 remaining principal towns of Ballykelly, Bushmills, Portrush and Rasharkin.
