3. CONFIDENTIAL LEGAL UPDATE

Confidential report, by virtue of paragraph(s) 5 of Part 1 of Schedule 6 of the Local Government Act (Northern Ireland) 2014 was previously circulated and presented by the Council Solicitor.

The report presented Senior Counsel's Opinion relating to the merits of challenging the PAC's decision to grant planning permission for the Magheramore Windfarm.

Background

An application for full planning permission, (Ref: LA/2019/0922/F) for a windfarm at Magheramore, Dungiven was submitted by the applicant Renewable Energy Systems (RES) on 02 August 2018.

The Planning Department presented a recommendation to the Planning Committee for decision. This recommendation was to refuse. This recommendation was accepted by the Planning Committee on the 22 November 2023. The decision issued on 5th December 2023. The applicant appealed the decision to the PAC. The appeal hearing took place on the 30 April 2025. The appeal was allowed on 31 July 2025.

At its meeting on 27 August 2025, the Planning Committee resolved to request a barrister to review the decision to ascertain whether there is a prospect of success of quashing the decision through judicial review.

Recommendation

The Opinion from Gregory Jones KC be considered. Senior Counsel

It is recommended that the Planning Committee follow the specialist legal advice sought from Gregory Jones KC.

In response to questions from Councillor McGurk, the Council Solicitor provided estimated costs moving forward with Judicial Review proceedings and in the event of being unsuccessful. In response to Councillor McGurk, the Council

Solicitor provided a view on the risk of Councillors' personal liability, the risk of legal challenge, complaint to NIPSO and reputational damage in the event of being unsuccessful. Advice was provided on the timeframe for Pre Action Protocol and Proceedings.

G Jones KC presented his Opinion and responded to questions from Planning Committee Members.
