- 4. The applicant has at all times been conscious of the need to avoid overdevelopment of the site and has carefully listened to community feedback through the course of the proposal to respond to points raised. This has resulted over the course of the design of the project in a reduction of proposed turbines from 12 at the outset, to 4 in the final proposal now before the committee (i.e. a reduction in number of turbines by two-thirds
 - over the design and planning phase).

5. The proposal was most recently amended in December 2023, reducing the number of turbines from 6 to 4 in response to feedback received. The 2 omitted turbines were the most elevated turbines. The scheme that is now before the committee is significantly reduced and has been arrived at following careful consideration.

- 6. The level of objection significantly reduced after the concession was made i.e., <u>before the amendment c.</u>

 1200 objections, after the amendment, merely 7 objections to the revised date.
- 7. Welcome that the Council officers have reached the recommendation without needing to have engaged in <u>any</u> outweighing of unacceptable adverse impacts through wider environmental, economic and social benefits.
- 8. While we acknowledge that there were third party concerns, we consider that they have been reasonably addressed through the concessions made through careful siting and design as well as amendment through the application stage. For example, the referenced critical views from Dungiven Castle and A6 which several objections focus on, now only show partial tips of three turbines from transient locations which is not considered to amount to an unacceptable adverse impact.
- Concerns that were also raised regarding the Benbradagh Masterplan 2024 are not sustainable particularly
 when the document <u>promotes</u> the need to for Climate Resilient Strategies to draw from renewable energy
 source.
- 10. There is significant support including from several community groups.
- 11. This proposal will make a positive and proportionate contribution towards tackling climate change and will deliver economic benefits in doing so.

Erratum Matters

- 1. Electrical output is 19.2MW this requires updating from the previous 28.8MW (given the turbine reduction).
- 2. Third party representation we previously raised a matter with the Council regarding the date of third-party representations against the date of submission/upload (post-dated the amended scheme).

The Council helpfully undertook in July 2025 to reconcile that in the PCR though this is yet to be reconciled:
