1. Apologies

Apologies were recorded on behalf of Councillor Hunter.

2. Declarations of Interest

No declarations of interest were recorded.

3. Nominations to Positions of Responsibility

Schedule 1 to the 2014 Act includes detailed provisions in relation to the filling of positions of responsibility and specifies the operation of the procedures that are available to the Council. The legislation sets out that positions of responsibility shall be filled using the calculation included in Schedule 1 of the Act unless the Council decides by qualified majority (80%) to apply one of other methods set out in Schedule 1, Part 2 to the 2014 Act.

Information on d'Hondt picks were prepared based on Schedule 1 of the Act and the new Committee structure and circulated to Members in advance of the meeting.

Members were also advised that Part 3 of the Local Government Act (Northern Ireland) 2014 specified the positions of responsibility which must be allocated across the political parties represented on Council in accordance with the provisions of the Act.

The Positions of Responsibility to be filled:

- i. Mayor/Chair
- ii. Deputy Mayor/Deputy Chair
- iii. Chairperson and Vice Chairperson of each Committee Audit; Corporate Policy and Resources, Environmental Services, Leisure and Development, Planning
- iv. External appointments Partnership Panel, Northern Ireland Housing Council, Reserve Forces' and Cadets' Association

3.1 Partnership Panel

It was proposed by Councillor Hillis, seconded by Councillor Baird and AGREED: that Council's appointment to the Partnership Panel be 4 separate appointments each for a one year term.

3.2 Northern Ireland Housing Council

5. Election of Aldermen

Regulation 4 of The Local Government (Transitional, Incidental, Consequential and Supplemental Provisions) Regulations (Northern Ireland) 2014 deals with the designation of aldermen and it outlines the following:

- 1) The ordinary election of aldermen shall be held at the annual meeting of the council.
- 2) The number of aldermen shall be such number as the council may determine but shall not exceed one quarter of the whole number of the councillors.
- 3) If the number of councillors nominated as a candidate for the position of alderman does not exceed the number determined by the council and the council so agrees, those nominated councillors may be deemed to be elected to the position of alderman.
- 4) If the above does not apply, an alderman shall be elected by the Council from among the Members.
- 5) The ordinary election of aldermen shall be held in every fourth year, being an election year.
- 6) A councillor shall be a candidate for election as an alderman if
 - i. he is nominated as a candidate by one other councillor as proposer and another as seconder; and
 - ii. he assents to the nomination
- 7) Any nomination may be made, and any assent may be given, either in the course of the meeting or by a document signed by the councillor or councillors in question and delivered to the clerk of the council before the beginning of the meeting.
- 8) A councillor entitled to vote at a contested election of an alderman shall do so by signing and delivering at the meeting to the clerk of the council a voting paper containing in order of preference the full names of the candidate or candidates for whom he votes.

It was proposed by Councillor Duddy, seconded by Councillor S McKillop and AGREED: that Council appoint 10 Members as Aldermen.

Councillor C McShane recorded her party's opposition to the appointment of Aldermen and proposed **that Council does not appoint Aldermen**, seconded by Councillor P McShane.

The Presiding Councillor put the amended proposal to the vote.

8 Members voted for and 23 against.

The Presiding Councillor put the original proposal to the vote.

23 Members voted for and 8 against.

The Presiding Councillor declared the motion carried that Council appoint 10 Members as Aldermen.
