#### 1. THE DEPUTY MAYOR'S BUSINESS

The Deputy Mayor opened the meeting by welcoming Elected Members, Officers, the public and press to the meeting.

## 4. PRESENTATION – DfI ROADS PROGRAMME – AUTUMN CONSULTATION

The Deputy Mayor welcomed the Department for Infrastructure representatives to the meeting, Mr D Porter, Mr A Montgomery and Mr J Middleton and invited them to present to Council.

Mr Porter stated that despite a challenging budget the Department was able to deliver a significant programme of resurfacing, pothole repairs and street lighting repairs. The Department had now secured additional funding and would therefore be able to deliver further road surfacing and street lighting upgrades together with routine maintenance on heavy trafficked roads.

Mr Porter commented on the opening of the A26 Frosses dualling, the A6 Road Improvement Scheme and the Dungiven to Drumahoe Scheme which will deliver 25km of new roads.

In relation to winter gritting services, Mr Porter added that the Department would be delivering a normal winter service with all the necessary staff and equipment ready to be deployed as and when required.

Representatives responded to Elected Members queries and concerns surrounding their respective District Electoral Areas and Members were invited to submit concerns through the Request/Enquiry Form circulated.

On behalf of Council, the Deputy Mayor thanked the representatives of Dfl for their presentation.

#### **Matters Arising**

# 7.1 Standby Fixed Generator Installation – Cloonavin and Mobile Generator for Business Continuity & Emergency Response to Serve other Council Facilities (Item 7)

Councillor Holmes stated that he did not believe that there was a need for two standby generators one in Cloonavin, Coleraine and one in Riada House, Ballymoney as agreed at the Environmental Services Committee Meeting of 7 November 2017, and proposed that Council accept the original recommendation.

The Director of Environmental Services informed Members that it would be possible to insert a tail to a static generator from which a mobile generator could link into and that the rationale is that Riada House would be the back-up for IT provision for Council. The proposal going forward would be for a static generator to be installed in Cloonavin for emergency planning purposes and tails left for a mobile generator in the facilities discussed. The cost estimated at approximately £5,000.

Councillor Clarke suggested that Council Officers should explore the opportunity that exists to sell generator capacity to third parties and feed into the grid as and when required.

Councillor Holmes was happy to incorporate this into his amendment.

The Director agreed it would be explored in further detail and brought back as part of the tendering process.

#### **Amendment**

Proposed by Councillor Holmes Seconded by Councillor Loftus

- to recommend that approval be given to progress the purchase of a standby static generator for Cloonavin and to include the investigation of tails at a number of key locations and that Council should explore the opportunity that exists to sell generator capacity to third parties and feed into the grid as and when required.

The Deputy Mayor put the amendment to the vote. 30 Members voted for, 0 Members voted against and 4 Members abstained. The Deputy Mayor declared the amendment **carried**.

Councillor Douglas presented the Minutes.

#### **Matters Arising**

At a meeting of the Leisure and Development Committee on Tuesday 14 November 2017, the Committee received a report and supporting information previously circulated to provide Members with an update on the development of a Bushmills Regeneration Plan, beyond the 2020 Village Plan.

At the meeting **it was recommended** on the basis that a Bushmills 'Arrival Hub' has an identified need, that AECOM refine the work relevant to Bushmills circulated through:

- Consultation with landowners / community groups / relevant stakeholders
- Establish the objectivity of need through proxy analysis
- Detailed cost analysis for each site
- Economic benefit derived through each site
- Capital funding opportunities

Facilitating the completion of the Outline Business Case and Economic Appraisal.

At the meeting it was **AGREED** that subject to a familiarisation site visit to Bushmills, that decision on the recommendation be deferred to the 28 November 2017 Monthly Council Meeting.

# 8.1 The Regeneration of Bushmills (Item 5)

Proposed by Councillor Hunter Seconded by Alderman Hickey and

**AGREED** – that following the familiarisation visit of the Leisure and Development Committee Members Council approves the recommendation that a Bushmills 'Arrival Hub' had an identified need, that AECOM refine the work relevant to Bushmills circulated through:

• Consultation with landowners / community groups / relevant stakeholders

- Establish the objectivity of need through proxy analysis
- Detailed cost analysis for each site
- Economic benefit derived through each site
- Capital funding opportunities

Facilitating the completion of the Outline Business Case and Economic Appraisal.

Upon a query from Alderman S McKillop in relation to the Dundarave Car Park Extension the Director of Leisure and Development clarified that early work had been done to give prioritisation and ranking but nothing would move forward until local extensive consultation with numerous groups had taken place.

In answer to a query from Councillor P McShane in relation to lands available the Director of Leisure and Development confirmed that since the meeting which took place the previous Friday one additional piece of land maybe in for consideration. Whilst it did not change the ranking of the existing sites identified, it would be included but doesn't change the process or potential outcome.

#### 8.2 Grants Programmes for 2018/2019 (Item 8)

#### **Commemoration Grants**

Councillor Knight McQuillan stated that a Notice of Motion had been agreed by Council in September 2017 which stated that funds would be set aside for the commemoration of the end of the Great War. Councillor Knight-McQuillan requested clarification from the Director of Leisure and Development as to whether the grant was specific to commemorations or to commemorations of the End of the Great War as the criteria set out did not make this clear.

The Director of Leisure and Development informed Members that the fund was conceived by Members in relation to annual historic events which community groups are seeking funding for; it was a general Commemoration Fund and not specific to the end of the Great War. He referred Members to Annex A of the original report (previously circulated) and the Grant Funding Policy.

#### **Amendment**

Proposed by Councillor Knight-McQuillan Seconded by Councillor Stevenson - to recommend that Council accepts the recommendation 2 of the Committee in relation to the Grant Programmes for 2018/2019 with the exception of the Commemoration Grant Fund for 2018/2019 and that detail and parameters of the criteria for this fund be defined and brought back to Committee.

The Deputy Mayor put the Amendment to the vote. 22 Members voted for, 12 Members voted against and 1 Member abstained. The Deputy Mayor declared the amendment **carried**.

**AGREED** - that Council accepts the recommendation 2 of the Committee in relation to the Grant Programmes for 2018/2019 with the exception of the Commemoration Grant Fund for 2018/2019 and that detail and parameters of the criteria for this fund be defined and brought back to Committee.

#### 8.3 Grant Funding Policy Annual Review (Item 7)

Alderman Cole enquired as to whether any preference should be given to those Groups and Community Associations that have historically been receiving grants for a large number of years.

The Director of Leisure and Development confirmed to Members that every grant application followed the same process and it was clarified in the policy that any Group or Community Association that received grants in the past did not automatically entitle them to receive funding in the future. Every single application is considered on its own merits on a case by case basis and no organisation is given preference or priority above any other.

The Director of Leisure and Development confirmed that the Funding Unit Manager runs regular Grant funding Workshops for all the Community Groups and confirmed he would ensure that Members would be made aware of when and where these will take place.

## 8.4 Play Strategy (Item 9)

Councillor C McShane commended the amount of work already done on this and enquired as to what weight was given to Council prioritising projects going forward.

The Director of Leisure and Development informed Members that as a consequence of the Audit carried out in the development of the Play Strategy, is it how Council therefore prioritise the works moving forward at the next stage. He confirmed that a report will be brought back to Council on the prioritisation process.
