3. REQUESTS FOR USE OF COUNCIL LAND

The Director of Corporate Services presented a confidential report previously circulated on requests for use of Council land for the Sub-Committee to consider.

The following factors were taken into account when considering each request:-

- Right of way issues
- Setting precedent
- Impact on Council's strategy
- Valuation
- Long term impact on Council's asset
- Legal implications
- Health and Safety, Insurance, Risk Assessments and Event Management Plans

3.1 (Ref 02/18) Request to use Council land at West Bay on 3 June 2018 for Ford Fair

The Director of Corporate Services (DCS) presented the report to use Council land at West Bay on Sunday 3 June 2018 for Ford Fair.

The Causeway Coast Ford Fair is a static motor vehicle display, where exhibitors display their own vehicles and the general public are invited to view them. The event is a Family Fun Day, therefore there will be kids entertainment, trade stands and music/ entertainment. 400 exhibitors plus visitor numbers of 10,000+ are expected. This event is now in its 14th years, held annually in conjunction with the Council, on the first Sunday in June. The Ford Fair was held at West Bay last year and previously at Dunluce Centre, Portrush.

3.2 (Ref 06/18 – 07/18) Use of Council Land at Waterfoot Beach, Benone Strand and Ballycastle Beach for UPC IFSA events on Sunday 14 January 2018 and Saturday and Sunday 10/11 February 2018

A request has been received from Ulster Provincial Council Irish Federation Sea Anglers UPC IFSA to use Council land for Open Gold Medal and Interprovincial shore championship Ulster 2018 at Waterfoot Beach on 14 January and 10/11 February 2018; Benone Strand 10 February 2018 and Ballycastle Beach on 10 February 2018.

There are usually approximately 60 participants from all 4 provinces participating in each of the events.

It is recommended that Council grants, in principal, approval of the request from UPC IFSA to use Council land at Waterfoot Beach, Benone strand and Ballycastle Beach for two events on 14 January 2018 and 10/11 February 2018.

4. LEGAL ISSUES

4.1 Beach Road, Portballintrae

The Land and Property Sub-Committee was advised by Council's solicitor of an area of land at Beach Road, Portballintrae which appeared to show an encroachment on to Council land.

A settlement has been negotiated with the current owner to reflect any interest Council may have had in the land. The sub-committee was asked to consider and make recommendation on the offer.

AGREED:

- (i) to recommend to accept the settlement and
- (ii) to recommend that Council registers its ownership of its land at this location.

4.2 Bayhead Road, Portballintrae

The Land and Property Sub-Committee was advised by Council's solicitor that a number of complaints have been received from members of the public pertaining to signage erected and a right of way for vehicles and pedestrians at a site at Bayhead Road, Portballintrae.

Council's Solicitor advised that the matter would be considered further by the legal team with regards to the options available. The sub-committee was advised that Council had written to the land owner on the matter.

In response to queries regarding the signage, the Development Enforcement Manager confirmed that the signage could be deemed for directional purposes and from the photograph it appeared to comply with size requirements, therefore Planning Permission was not required.

Following discussion on the matter it was

AGREED: to obtain legal advice and bring a further update to the February 2018 Land and Property Sub-Committee meeting.
