### 1. THE MAYOR'S BUSINESS

The Mayor opened the meeting by welcoming Elected Members, Officers, the public and press to the meeting.

She addressed the meeting as follows:

"Good evening everyone and welcome to our full Council meeting and subsequently my last one as your Mayor.

I know it is a much used phrase, but where does the time go?

I cannot believe that is it nearing the end of my year as Mayor of Causeway Coast and Glens Borough Council. And what a year it has been.

I would firstly like to begin by extending my heartfelt sympathy to Councillor Fitzpatrick's wife and family members at this very sad time. His presence will be greatly missed in the Council chamber where his integrity and commitment to enhancing and promoting the Borough were always to the fore. I'm sure you will all join me in saying that our thoughts and prayers are with Councillor Fitzpatrick's family at this tough time".

The Mayor invited Council to Stand in Silence in memory of Councillor Fitzpatrick.

"Since we last met, I have had a very busy month of events and engagements. I was delighted to host two Freedom ceremonies for Sir Denis Desmond and Mrs Joan Christie. Both occasions were terrific achievements for our new Freemen, their family and friends and for the Council itself. I thoroughly enjoyed each day and they will both remain a highlight in my career as the Mayor. As you all know the Freedom of the Borough is the highest accolade which a Council can bestow and it was a huge privilege for me to be a part of these proceedings.

It received the recognition from Council after staff and pupils demonstrated an ongoing commitment to cutting down their reliance on single use plastic items. I thoroughly enjoyed my visit to the school where the children proudly showcased their ongoing good work.

Looking ahead, the Borough will look forward to the Rathlin Sound Maritime Festival beginning this week and the Bushmills Salmon and Whiskey Festival. ### 4. PRESENTATION – TOURISM IRELAND

The Mayor welcomed N Gibbons and colleagues to the meeting.

N Gibbons presented via PowerPoint on Tourism Ireland's activities to promote the Causeway Coastal Route and Northern Ireland in main worldwide markets and invited Council to view marketing campaigns on *Words of Seamus Heaney, How To explore the Causeway Coastal Route* and *NI Game of Thrones Tapestry* Campaigns.

N Gibbons responded to Elected member questions and comments surrounding the standard of food production in Northern Ireland as a valuable asset in job creation within Tourism and how this market presence could be raised; GAA Tourism that required brown signage and local Économusée attractions within the area; clarification of the expenditure of the Tourism Ireland budget; the potential of advertising at Airports, opportunities for Tourism along the River Bann, Brexit, infrastructure for Coaches to enable longer stays and the effect of the depreciation of Sterling against the Euro.

N Gibbons agreed to forward promotional material each on The Glens of Antrim and Limavady to Members enquiring.

# 6. LEGAL OPINION IN RESPECT TO A CALL-IN IN RELATION TO EDWARD STREET SOCIAL CENTRE

Council's Solicitor presented Advice to Council in respect of a Call-In received by the Chief Executive in challenge to a decision of Council of 27th March 2018 in relation to item 12 of the Leisure and Development Committee minutes.

Councils Solicitor advised the matter should be reconsidered by Council. CM\_180522\_SAD Page 10 of 25 Councillor Wilson read from a prepared statement and proposed an Amendment.

"Council acknowledges that Causeway Coast and Glens Borough Council and Ballymoney Borough Council have run Edward Street Social Centre over a period of years even though the building was owned by NICVA. In returning the building to NICVA Council will carry out remedial works to bring the building into a satisfactory state;

Acknowledging the situation inherited from Ballymoney Borough Council relating to the ownership of Edward Street Social Centre;

Also acknowledging that since 2015, Council's policy is to apply an objective evidence based approach to the provision of services and facilities;

Therefore Council now finds itself in a situation, which requires a responsible course of action having established that the evidence of need does not support major capital investment in the facility, reinforced further having confirmed that NICVA own the facility and Council does not;

Therefore in order to demonstrate Council's commitment to a responsible approach"

### Amendment

Proposed by Councillor Wilson Seconded by Councillor Holmes

- it is proposed that prior to transferring operational responsibility,
Council undertakes the necessary maintenance works to ensure that the facility is serviceable, at an estimated sum not exceeding £75K;
The necessary works include renewal of all electrical installations, decoration of the facility and the provision of a new kitchen;
The aforementioned work is to be completed within a 6 month period, facilitating the end of Council's operational responsibility no later than 23<sup>rd</sup> October 2018.

Council debated the matter. Council's Solicitor, the Chief Executive and the Director of Leisure and Development responded to questions and requests for clarification concerning the following issues raised: how the amendment fits in with Council's procedures and protocol; the case for precedence, if any, within in a set of exceptional circumstances; the fact that NICVA were the owners of the building; whether another Call in could be made; whether other facilities would have a case to take legal action; surcharges on Councillors; where the additional money would be found; recourse, if any, for leaving the building in its current state; external Groups who had sought funding streams via Council's application process; whether discussions had taken place with NICVA on the proposed amendment and whether Planning committee members could vote; Council's Audit of Needs analysis and whether the building was ever listed as an asset.

Councillor Mulholland requested a Recorded Vote on all motions in relation to the Item and a recess before the vote be taken.
