## 4. PRESENTATION BY DfI ROADS – AUTUMN CONSULTATION 2019:

The Mayor welcomed D Porter, Divisional Roads Manager, A Montgomery, Section Engineer Causeway Coast & Glens (West) and J Middleton, Section Engineer Causeway Coast & Glens (East) and invited the representatives to present to Council.

D Porter referred to the DfI Roads, Northern Division Interim Report, Autumn 2019, previously circulated and proceeded with the report as read. D Porter advised, that since its publication, a significant amount of money had now been secured, a £75M Structural Maintenance allocation of which, £10M towards maintenance to target roads badly affected, whilst £142M per year was required, an additional £7.58M had been secured for Structural Maintenance, £3M for Minor Works and Local Transportation and Safety Measures (LTSM), a further £5M for Street Lighting repairs and LED improvements. Further detail was provided.

D Porter advised of a significant Closure of the A6 due to the Dungiven to Drumahoe Scheme Friday evening – Monday morning.

Dfl Representatives responded to Elected Member queries and concerns surrounding their respective District Electoral Areas. The Divisional Roads Manager responded to each individual comment, question and concern.

In response to a request for clarification, the Director of Leisure and Development stated the total cost of the programme was £634,503 for 3 years, Council had been asked to fund £20,000 per year for 3 years.

The Mayor put the amendment to the Council to vote. 25 Members voted For; 0 members voted Against; 6 members Abstained. The Mayor declared the amendment carried.

## 10.3 Riverside Theatre (Item 9)

Amendment Proposed by Alderman McCandless Seconded by Alderman Boyle

- that Council defer the reduction of 10% of the annual budget to Year 2021.

The Mayor put the amendment to the Council to vote. 12 Members voted For; 15 Members voted Against; The Mayor declared the amendment lost.

## 10.4 Causeway Coast and Glens Heritage Trust (Item 6)

Proposed by Councillor Holmes Seconded by Councillor Baird and

- that Council invite representatives from Causeway Coast and Glens Heritage Trust to present to Council before the next financial year.

The Mayor put the motion to the Council to vote. 34 Members voted For; 0 members voted Against; 0 Members Abstained. The Mayor declared the motion carried.

## 10.5 AORB Portaneevy (Councillor Baird) (Item 25.1)

Councillor Baird stated Council had been offered DAERA funding of approximately  $\pounds$ <sup>1</sup>/<sub>2</sub> M for the iconic Portaneevy Scheme, Council's contribution would be approximately 5%-10%. Councillor Baird envisaged the Scheme would be a great boost for Tourism and local people, in a socially deprived ward, it would be remiss of Council not to proceed.

In response to requests for clarification, the Director of Leisure and Development stated he was not aware of 100% funding opportunities for the Portaneevy Scheme. The Director of Leisure and Development advised of resource limitations and deliverability within Council's Project Team, it was unlikely the project would be delivered within Rural Development Programme timescales.

Councillor Baird proposed Council proceed with the Portaneevy Scheme and avail of approximately  $\pounds \frac{1}{2}$  M DAERA funding; that Council additionally use funding from landfill tax and engage a Consultant.

Councillor C McShane advised the Portaneevy Scheme had been available prior to the Magheracross Scheme and was within Council's Blueprint for the Causeway Coast Way route from Portstewart to Ballycastle and supported Councillor Baird.

Councillor MA McKillop stated her support, for a small investment.

Alderman Hillis stated his support, for what may cost Council £24,000.

Councillor Beattie referred to Council's recent decision regarding Magilligan Ferry Terminal, Councillor Beattie had envisaged this efficiency would go towards promoting Council's Tourism industry, such as this.

Alderman McKillop questioned whether other projects in need would be pushed back.

The Director of Leisure and Development underpinned, the resources to deliver the projects did not exist and would result in delay delivering the prioritised projects list.

This Council will write to the Permanent Secretary for Health Mr Richard Pengelley highlighting the difference in the screening service provision across the UK and Ireland and calling for a review into Bowel Cancer Screening services in the North and to follow the English NHS lead in trialling Breast Cancer Screening at a lower age here in Northern Ireland.
