The Mayor opened the meeting.

The Mayor took the opportunity to congratulate Council Officials who won the award for 'Excellence in Environmental Sustainability' at the recent Local Government Awards.

The Mayor highlighted recent Mayoral Receptions including one he held for Eoghan Ruá GAA, who he advised had an excellent year last year and won many titles.

The Mayor held a reception for 3-year-old Dáithí MacGabhann from Belfast. Dáithí and his family were raising awareness about organ donation through

Councillor McQuillan offered congratulations to Coleraine Football Club on their recent League Cup win. The Mayor concurred and informed Council he was holding a Mayor's Reception for the Coleraine Football Club Team.

The Mayor invited G Thompson, Chief Executive (CC&GHT) and G Seymour, Chairman (CC&GHT) to the meeting and invited them to present.

G Thompson and G Seymour presented detail via powerpoint on the activities of the Causeway Coast and Glens Heritage Trust, their 2019-2020 highlights, Council funding, the impact of any removal of funding and activities for 2020 and beyond.

Councillor C McShane requested an update on Council activities to date and Geopark development.

G Seymour clarified Council's Letter of Offer had been received, funding had been reduced from £35,000 to £16,000 and work was nearing completion on activities carried out to date.

6.1 Strike the Domestic and Non-Domestic Rate 2020/21

Councillor McQuillan commented, the rate set by Council was 7.65%, however, the following day it had been reduced to 7.45% and questioned how it could be changed.

The Chief Finance Officer advised Council agreed the budgets and when looking at the rate factors of 7.65% on the domestic rate and 0.01% on the non-domestic rate and after completion of the annual return, DFC advised the final revision to the conversion factor, converting the non-domestic rate to the domestic rate and that was the effect.

Councillor C McShane concurred with the previous speakers comments. She advised she was unclear of the efficiencies made. Councillor C McShane sought confirmation from senior management that all known costs were included in the rate setting process.

Councillor C McShane referred to the Council meeting audio recording, she requested that Members turn on their microphone during a recorded vote as it was not obvious when a Member had left the room.
