The Mayor advised Council of its obligations and protocol whilst the meeting was being audio recorded.

SUSPENSION OF STANDING ORDERS

The Mayor advised that due to the unforeseen weather conditions, Council needed to suspend Standing Orders to allow a hybrid meeting to take place.

The Chief Executive put the suspension of Standing Orders to the Vote.

The Chief Executive undertook a roll call.

1. APOLOGIES

Apologies were recorded for Councillor Kennedy, Councillor McShane, and Councillor Wallace.

* Alderman Callan joined the meeting remotely at 7.08pm.

2. THE MAYOR'S BUSINESS

The Mayor stated:

I would like to welcome you all back to Chamber and hope you all had a great Christmas and New Year. As we reflect on last month, it was a privilege to have had the opportunity to highlight the remarkable talents of our young people. We celebrated Larissa Fleck, a national title holder in both Festival Irish dancing and Irish Harp. Additionally, we congratulated the under-13 Ballymoney girls football team for their impressive victory in the Foyle Cup at their age group. We were also fortunate to attend Sandelford School, for Katelynn Marie's exceptional Christmas performance. It was equally important last month to show our support for the Donate for Dáithí campaign and raise awareness of Organ Donation Discussion Day about the critical significance of organ donation.

I would like to express my gratitude to the Deputy Mayor for her continued support and for stepping in during my absence when I was unwell. Furthermore, I was deeply moved by the Samaritans Christmas vigil, where I had the privilege of speaking with their dedicated volunteers. I encourage anyone in need of assistance to reach out, as help is always available. Councillor McGurk advised Members that a previous councillor, Councillor Tony McCaul, had died over the Christmas period, and she sent condolences to his family and colleagues.

3. DECLARATION OF MEMBERS' INTERESTS

The Chief Executive declared an Interest in Item 4 and advised that the Director of Corporate Services would take over from him during this Item. Having declared an Interest, the Chief Executive left the Chamber during discussion of this Item.

Alderman Hunter declared an Interest in Item 11, Minutes of Leisure and Development Committee meeting held Tuesday 17 December 2024, in respect of Item 19.1, AORB – Merrow Hotel and Spa, as a Member of the Planning Committee. Having declared an Interest, Alderman Hunter did not disconnect from the meeting during discussion of this Item.

During discussion of Item 14(ii), Correspondence – Minerals and Petroleum Branch, Department for the Economy, dated 6 December 2024, Councillor Storey declared an Interest as a Member of the Planning Committee. Having declared an Interest, Councillor Storey did not leave the Chamber during discussion of this Item.

* The Chief Executive left the Chamber at 7.10pm.

4. DEPUTATION – PROFESSOR PAUL BARTHOLOMEW, VICE-CHANCELLOR, ULSTER UNIVERSITY

The Mayor welcomed Professor Paul Bartholomew to the meeting.

Professor Bartholomew thanked the Mayor for the opportunity to present to Council and noted that some Members had recently participated in a tour of Coleraine campus. He then delivered a presentation to Council, on Coleraine Campus Student Numbers and Future Campus Enhancements, the key points of which were:

- The current Coleraine on-campus student number is 3294. There is also about 1000 distance learners attached to programmes there.
- There has been some growth on the previous year, consistent with the aspirations for the campus, with about 200 more students on campus.
- There are currently about 99 programmes offered at Coleraine.
- Veterinary Nursing is new for next year.
- Adventure Sport and Sport and Exercise Nutrition have been new additions.
- Applications for 2025 across the Coleraine programmes are buoyant.

- The Coleraine Campus focus is one of enhancement with a small amount of growth, and enhancement of the campus estate.
- Ulster University is a unitary institution.
- The People, Place and Partnership strategy has 9 commitments, one of which is around a better campus balance. This is about a shift of emphasis in the student numbers away from Belfast and onto other campuses.
- The Taskforce report emphasises additionality at Derry-Londonderry, but also emphasises protectiveness of the existing provision across the region. It is not zero-sum; rather, it is about giving more opportunities to young people for growth.
- He then provided an overview of planned campus enhancements: Project 1 External Enhancements and Project 2 – Internal Enhancements.

The Mayor thanked Professor Bartholomew for his presentation and invited Members to ask questions.

- * Alderman John McAuley joined the meeting in the Chamber at 7.30pm.
- * Councillor Schenning joined the meeting remotely at 7.30pm.

Councillor Storey referred to a presentation from the Vice Chancellor's predecessor in 2018, in which promises were made for the Coleraine campus of a Veterinary School and a post-primary secondary school. He stated that there is a politically motivated concentration on Magee, whereas the investment plans for Coleraine do not add additional students to the campus. He said that it was previously stated that psychology would be consolidated at Coleraine, but he was concerned that it may be moving to Magee.

The Vice Chancellor stated that psychology is not moving from Coleraine, but that consideration is being given to duplication at Magee. He stated that there are more applicants than can be accommodated so there is an opportunity to run it in more than one place to respond to demand and to provide more opportunities for people. He emphasised the importance of the university having a dynamic response to demand. He emphasised that Ulster University is a unitary institution rather than the campuses being seen as separate entities.

Councillor Storey stated that the university is the largest employer in the area and an economic driver here. He expressed concern that substantial growth at the Magee campus could affect the Northern Regional College. He stated that the City and Growth Deal is putting £20 million into Ulster University but the planned works will not increase student numbers.

The Vice Chancellor clarified that none of the City and Growth Deals are linked to student numbers and that the funding would contribute to a drug discovery and food innovation centre.

Councillor McCully noted that, anecdotally, it seems that the squeezing of student finance has had an affect on student life on the north coast, which has affected his DEA, particularly Portstewart. The Vice Chancellor acknowledged that the phenomenon exists and that cost of living expenses changes how students engage. He referred to the commitment in the People Place and Partnership strategy to having a vibrant campus-based higher education model. He advised that the review of the funding model for higher education in 2025 may be a good opportunity to address how students are supported in their learning.

Councillor McCully stated that the plans presented for Coleraine campus are a reassuring indication that the university is trying to embrace and develop a social life on campus.

In response to a query from Councillor Wisener about the £16.3 million investment allocated to ethical artificial intelligence, the Vice Chancellor clarified that the Artificial Intelligence (AI) Centre is distributed across the whole of the university, and that Queen's University is also a partner. He advised that undergraduate artificial intelligence programmes are offered at Magee, but that the investment will be spread across multiple institutions.

Alderman Callan asked what the university's ambitions are for growth at Coleraine over the next five years, and asked about the cost of the capital works at Coleraine campus and the timeframe for the completion of these. The Vice Chancellor advised that the estimated cost is £15million and that the work will be carried out over a number of years, as the campus will remain in use throughout. In respect of growth of student numbers, the Vice Chancellor advised that NI and ROI student numbers are capped here and that there is more demand than supply due to the constrains of the funding model here, which is much more constrained than the rest of the UK, even Scotland.

In response to a query from Alderman Callan regarding a veterinary school, the Vice Chancellor advised that a decision on this is in the hands of the NI Executive. He stated that Ulster University would bid to host a veterinary school at Coleraine if funding were proposed, and that the new Veterinary Nursing programme is intended to put Ulster University in the best position for that, but there is no sign that such funding in pending. He further advised that another projected capital investment could be in a hotel at the campus, allowing the university to run a hospitality programme, if funding for such a venture were provided.

Alderman Callan stated that Ulster University needs to keep engagement with the local community to provide assurance of its commitment to the Coleraine campus. The Vice Chancellor stated that the university is committed to all of its campuses

and that he would consider having a community open day at the Coleraine campus.

Alderman Boyle noted that Ulster University had been awarded 'University of the Year 2024' by Times Higher Education. In response to her query regarding the Riverside Theatre, the Vice Chancellor advised that the theatre is under review and requires quite a lot of capital infrastructure improvements, so he is not in a position to provide an assurance on its future.

In response to Councillor Anderson, the Vice Chancellor advised that there are no current plans to reinstate the business programme at Coleraine but that if it were sensible and viable for that programme to return to Coleraine, it would be considered.

Councillor N Archibald stated that Ulster University has become a world leader in research. In response to her question about how the university envisages working collaboratively with the regional colleges, the Vice Chancellor advised that the university regards the regional colleges as its partners and that the university's regional partnership managers work with the colleges on opportunities for collaboration, and that the university provides a range of articulation agreements in respect of the foundation degrees offered by the colleges.

Councillor Storey noted that this year marks the 180th anniversary of the opening of Magee and asked if the university planned to mark this. In respect of the renovations at the building, Councillor Storey asked for sensitivity around the five doors being taken away at the front of the university. The Vice Chancellor advised that he was not aware of plans to remove doors and would investigate this, and he reassured Councillor Storey that the plan for the building was to restore its historical grandeur to make the interior more fitting with its external appearance.

There being no further questions, the Mayor thanked the Vice Chancellor for his presentation.

 Alison Allen, Chief Executive, NILGA, NILGA Leadership Development Programme for Councillors 2025, dated 12 December 2024 (copy previously circulated)

Extract

NILGA is delivering CPD Standards, 8 Module Accredited Leadership Development Programme for elected members, which aims to develop the practical skills necessary for a strategic understanding of the context within which councillors work (people, place and systems) and the capabilities they need, using relevant models and concepts to help them improve their strategic leadership approach in a local political environment. The Leadership Programme will commence on the 31st January 2025 and will run each month up until the Autumn 2025. NILGA seeks nominations based on your own determinations, which we ask you seek at the earliest possible full council meeting.

Costing estimate

Individual participant cost will be subject to the overall number of the cohort nominated for the Leadership Programme 2023-24; based on a cohort of 20, we can provide an indicative cost of £730 +VAT.

There will be an opportunity for those Councillors who are interested in and committed to achieving CPD accreditation from the CPD Standards Office. This will involve additional costs to the figure provided above - indicative costs at this stage are a further £590 +VAT. Those who wish to register and commit to CPD accreditation will have a deadline within which to do so (typically, at the end of the second module).

The Chief Executive advised Members that the training will commence on 31st January. He stated that there is an opportunity for any Member who wishes to attend to do so. He advised Members that they could propose names for the training at this meeting or forward names to Democratic Services subsequent to the meeting.

(ii) Minerals and Petroleum Branch, Department for the Economy, dated 6 December 2024

Extract

Dear Stakeholder, The Department previously contacted you about the consultation on onshore petroleum licensing policy in Northern Ireland (a link to details was previously circulated).

On 05 December 2024 the Executive endorsed Minister Murphy's final policy position to introduce a temporary moratorium and eventual legislative ban on exploration and production of all forms of onshore oil and gas. A moratorium on the acceptance and processing of petroleum licence applications is now in place and legislation will be brought forward in the coming months to enact a full ban.

A link to the departmental press release was previously circulated.

Councillor Storey drew Member's attention to this correspondence regarding a decision by the NI Executive to introduce a moratorium on oil and gas exploration. He stated that there are also objections to offshore wind farms and other green energy sources. He declared an Interest as a Member of the Planning Committee. He stated that there is an energy crisis and that the energy will have to come from somewhere.

(iii) Susie McCullough, Chief Executive, Ards and North Down Borough Council, Nappy Collection Scheme, dated 13 December 2024 (copy previously circulated)

Extract

At the November Council meeting of Ards and North Down Borough Council, the following Notice of Motion was agreed:

"That this Council notes the 70% recycling target set out in the Climate Change Act 2022 and that the current household recycling average is 50.7%. Further notes the aims and intentions around the consultation on "Rethinking our resources: measures for climate action and a circular economy in NI" includes the reduction in grey bin capacity by either volume of bin or three weekly collections. Further notes that nappy collection scheme was not referred to in Rethinking our resources: measures for climate action and a circular economy in NI" despite around 4% of residual waste being made up of disposable nappies and other absorbent hygiene products. Further notes with concern the impact reduced grey bin capacity will have on those households disposing of nappies and/or other absorbent hygiene products as well as the amount of recyclable materials such products contain.

This Council writes to the Minister of Agriculture, Environment and Rural Affairs expressing its view that there is a need for a nappy collection scheme in Northern Ireland in order to meet recycling targets and to support households if grey bin capacity is reduced as a result of any future Departmental strategy and, further, that this Council would be happy to engage with the Department on how to best deliver such a scheme. And that a copy of this motion is sent to other Councils in Northern Ireland to encourage them to write to the Minister on similar terms."

Re: Notice of Motion – Gender Based Violence Against Women

At a Meeting of Newry, Mourne and Down District Council held on 2 December 2024, the following Notice of Motion was agreed:

"That this Council notes the growing concern regarding the epidemic of gender-based violence against women. This concern has been heightened by recent sexual assaults in Derry and the tragic deaths of five women in the past seven weeks in the North.

In response to this, this Council writes to the Justice Minister and the Justice Department, urging them to expand the categories of "significant persons" when applying for a Non-Molestation Order, to include individuals who were in a significant relationship but did not cohabit. This would align with the provisions in the UK, where similar protections are offered, and with the "Safety Order" provisions in the Republic of Ireland.

Additionally, this Council calls on other councils in the North to support this motion, thereby advocating for the extension of similar protections to women in the North, ensuring they are afforded the same legal safeguards as those in the UK and the Republic of Ireland.

That Council write to the Lord Chief Justice asking for a review of how male offenders who have offended against women are given bail".

I have been asked to write to each of the Councils requesting support for this motion and would ask that you give this matter serious consideration. I look forward to your response.
