## Notification of Adoption of the Derry City & Strabane District Council Local Development Plan (LDP) Plan Strategy

Further to my previous letters on this matter, I now write to advise you that Derry City & Strabane District adopts the Derry City & Strabane District Council Local Development Plan (LDP) 2032 - Plan Strategy on 10th July 2025. The policies in the LDP Plan Strategy (PS) have already begun to be applied, to a given weight, in accordance with legislation, strategic Planning policy and case law. Full implementation of the LDP PS will apply immediately upon its Adoption and the strategic policies of the existing Area Plans (the maps / zonings still remain, generally, until the LDP LPP) and Planning Policy Statements will no longer be material, even for Planning applications that are already in the system (SPPS para 1.11: Transitional Arrangements).

The LDP Plan Strategy, the Adoption Statement, the Planning Appeals Commission (PAC) report into the Independent Examination, the Direction from the Department for Infrastructure (Dfl) and the Council's Appraisal of the Sustainability of the LDP Plan Strategy, are all published and are available to view online at the following weblink:

Any comments on any of these Draft SPG documents should be submitted in writing to the above-mentioned Strand Road office or email address, **before 4th September 2025**. A further tranche of SPG documents will also be consulted-upon from September / October 2025; please see the webpage for details at that time.

Derry City & Strabane District Council will now formally **commence the preparation of the Local Development Plan (LDP) Local Policies Plan (LPP)**. The public is not required to take any further action or make any submissions at this time. This LPP will be undertaken in accordance with the Planning (LDP) Regulations (NI) 2015 and the Council's published LDP Timetable and Statement of Community Involvement (Planning, SCI) (both documents are under review, available on the Council website).
