Good afternoon,

HED is writing to advise that formal listing consultation on 9 structures in your council area will be issued by the Department on 24/10/2025. This early alert is to provide Councils with additional time to allow planning and addition to the agenda for committee meetings, in advance of formal consultation taking place.

This will help reduce the request for extensions of time regarding a proposed listing, which leaves a building vulnerable for longer. Councils may wish to consider issuing a building preservation notice, a form of temporary listing which provides statutory protection to an unlisted building, for a period of 6 months, as if it were listed, in cases where the tests for doing so are met.

The structures which we will be issuing consultation on 24/10/2025 are detailed below:
