# 20.1 Effects of fireworks on pets and livestock

Councillor Johnathan McAuley

"Could we discuss the ill effects of fireworks and bangers on pets and livestock?"

Councillor McAuley stated that although he is not against firework displays, he has received a lot of communication regarding their effects on pets and livestock. He suggested that silent displays might help to mitigate this negative impact.

The Director of Environmental Services suggested that the item be referred to the Leisure and Development directorate, as the Leisure and Development Events team administers the contracts for Council fireworks displays.

Councillor Huggins agreed that this is an issue but stated that Council will not be able to stop people setting off fireworks in areas such as the countryside. She noted that the noise of fireworks can also affect veterans and others with PTSD.

Councillor Kane noted that when Council previously discussed this topic, drone displays were suggested, and this could be raised in the Leisure and Development Committee.

In response to a query from Councillor Kane, the Director of Environmental Services advised that he would look into the impact of fireworks displays in the context of the Climate Action Plan, and noted that some coastal displays can result in debris going into the sea.

Councillor Callaghan agreed that this is a problem but cautioned that silent fireworks displays are significantly more expensive.

Members discussed issues around licensing of fireworks. The Director of Environmental Services agreed that he would raise the issue with the Leisure and Development directorate and would feed into a paper on the matter, and include information on the role of the Department for Justice in respect of licensing fireworks.

Councillor McAuley stated that he was happy to refer the Item to the Leisure and Development Committee.
