1.0 Purpose of Report

The purpose of this report is to present an update on the activities undertaken by the Sperrins Partnership Project and to seek approval for an additional request for funding.

2.0 Background

- 2.1 The Sperrins Partnership Project is a collaboration between 4 Councils; Causeway Coast and Glens Borough Council, Derry City and Strabane District Council, Fermanagh and Omagh District Council and Mid Ulster District Council, who in 2018 committed to equal financial contribution towards the delivery of this project.
- 2.2 Project activity is overseen by a Project Officer and part time Administrative Support who took up their respective roles in October 2020. Derry City and Strabane District Council agreed to lead on the recruitment and employment of the officers in agreement with the partner councils.
- 2.3 At the June 2024 meeting of Leisure & Development Committee it was recommended that Council provide increased financial support through a £3,000 per annum uplift for 2025-2026 for the continuation of the Sperrins Partnership at a cost of £25,000 annually. Additionally, an extension in the period of Council funding from April 2026 to March 2027 with an annual contribution of £28,000 was recommended, subject to confirmation of the reciprocal financial contribution of all partner Councils.

3.0 Update from Sperrins Partnership Project

- 3.1 As part of the update to Council, Sperrins Partnership has provided three documents which are attached for members consideration.

1. Purpose of Report/Recommendations

1.1 The purpose of this report is to provide Members with an update on the Sperrins Partnership project activity that has taken place since the last update provided in March 2025.

2. Background

2.1 The Sperrins Partnership Project (previously Sperrins Future Search) is a collaboration between 4 councils; Causeway Coast and Glens Borough Council, Derry City and Strabane District Council, Fermanagh and Omagh District Council and Mid Ulster District Council, who back in 2018 committed to equal financial contribution towards its delivery and have also funded the Sperrins Future Search initiative. The 4 Councils have agreed to equal financial contribution towards the project until 2027.

3. Key Issues

3.1 Developing a Management Plan for Sperrin AONB

Members may recall receiving an update to October 2024 Committee that the Sperrins Partnership had secured 5-year funding through the DAERA Environment Fund Strategic Strand 2023 - 2028 to enable the Partnership to develop the first ever Sperrin Area of Outstanding Natural Beauty (AONB) Management Plan. This is a long-standing matter which the Sperrins Partnership Board had supported as a key issue facing the region.

The consultation to inform the development of the AONB Management Plan is now complete. The consultation exercise was delivered by an external consultant and took place between February and August 2024. The aim of the exercise was to carry out an extensive consultation that would gather the views of all key stakeholders, including members of the community who live and work in the Sperrins. The results of this consultation were made available to Members in October 2024 before they were presented at a public event held in November 2024. The report can be accessed via the link – Sperrin AONB Management Plan - Sperrins Partnership Project.

The next important phase in the project delivery was to convene 2 Action Plan Working Groups to help shape and develop the 5-year action plan. Expressions of Interest from a broad range of sectors and groups were gathered from November 2024 to February 2025. The group membership included a wide and comprehensive range of stakeholders which included council officers from various departments.

External support was secured to assist the Sperrins Partnership Team with design and delivery of these important working groups. 6 working group meetings were held from March concluding in October 2025 all of which have been in-person meetings with one meeting held online. This concludes with almost 18 months of consultations to date and 15 in person events held right across the entire AONB. The consultation has been noted one of the biggest ever carried out by a Landscape Management Body and the actions identified have gone through a rigorous process to get to this draft stage. The draft action plan was shared with DAERA at the end of October. As the project funder, DAERA is the body responsible for signing off on AONB Management Plans and their internal review process could take up to 3 months to complete. Once the plan has been approved by the department, a launch event will take place in the Spring of 2026 date tbc.

The overarching Management Plan is progressing on time and within budget and will be submitted to DAERA by the end of this year for review and signoff. Members will be kept up to date on all activities relating to the 5-year action plan and the 10-year Management Plan. A copy of the Sperrin AONB 5-year Action Plan is attached at Annex B.

Once the Management Plan has been approved it will be shared with Committee in advance of a formal launch event which is planned to take place in the Spring of 2026 date tbc.

3.2 Sperrins AONB Project Officer

The Sperrins AONB Project Officer will commence maternity leave on 9th February 2026. The post is funded by the DAERA Environment Fund. The department have advised that they will continue to fund the post (maternity cover) however they will not cover the additional maternity leave costs. The total additional maternity costs required to be covered by the partner councils are approximately £16,000. Therefore, there will be a need for these additional costs to be absorbed at a sum of £3,000 per council with the remainer absorbed by the Sperrins Partnership Budget. Cover for the post will be trawled internally across the 4 partner Councils simultaneously. The post will be offered on a temporary basis for a period of 1 year. Members will be kept updated on the Sperrins AONB Project Officer post.

3.3 Governance and Management Structures

The Partnership Project Management Group are considering options for project Governance and Management structures. A new structure will be necessary to ensure that the Sperrins Partnership can deliver on the needs and aspirations of the forthcoming AONB Management Plan and associated increase in project delivery. Governance and Management Structures proposals will be brought to a future meeting of this committee for consideration and approval.

3.4 Sperrins Walking Festival

Council officers across the 4 local authorities are currently considering proposals to deliver a Sperrins Walking Festival in Spring of 2026. The lead team for developing this proposal within Causeway Coast & Glens Borough Council is Tourism & Recreation. The proposal will include 4 x heritage focused site visits and multiple walks across the AONB. A consultation with local communities will commence in November 2025. The focus of the project is to connect communities with each other and their landscape through activities and experiences that aim to celebrate the people and place. Another key output is to attract visitors from outside the area and encourage more bed nights, benefiting the local economy. The proposal aligns directly with the feedback from AONB consultation and emerging actions in the 5-year action plan. Members will be kept up to date on developments of the Sperrins Walking Festival.

3.5 Sperrins Heritage Conference

The Sperrins Partnership has secured funding through the Department for Communities (DfC) Historic Environment Division (HED) Revivals Scheme to a value of almost £10,000. The Letter of Offer is attached at Annex C. Some of this funding will be used to deliver a Sperrins Heritage Conference. The aim of the Conference will be to connect a wide range of key stakeholders with their heritage and each other. The event will involve key speakers and provide an opportunity for participants to learn and engage in all aspects of their heritage and provide key insights into their own local heritage. Planning is underway for the Conference, and it is hoped that it will take place early in the New Year. Further information and invites will be issued closer to the time. Again, this proposal aligns directly with the feedback from AONB consultation and emerging actions in the 5-year action plan. Members will be kept updated with developments for the Conference.

3.6 Landscapes NI Annual Conference 11th November 2025

The Sperrins Partnership is a Member of Landscapes NI which is a network of organisations which together champion the restoration of diverse and iconic landscapes for the benefit of nature, health, economy, and the planet. This is achieved through advocacy work with government for improved policy and legislation to help restore nature in our landscapes, ensure they are accessible to all and promoting our landscapes to the public. There are 15 member organisations involved.

Landscapes NI will host its annual conference named 'Natural Health' which will take place on 11th November at the Silverbirch Hotel with site visits for delegates taking place in the Sperrins the following day. Conference speakers include Cairngorms, EUROPARC and RSPB. 3.7 Sperrin Outdoor Activity Development Officer - The Outdoor Partnership (TOP)

The Sperrins Partnership in collaboration with Sport NI and Partner Councils secured funding through The Outdoor Partnership (TOP) to appoint an Outdoor Activity Development Officer for the Sperrins for a 4-year funded period. The council has committed to fund the post to the value of £4,000 per year up to September 2026. The Sperrins Partnership team work closely with the Sperrin Outdoor Activity Development Officer to assist and support delivery of a range of projects that benefit communities through enhancing lives through outdoor recreation.

Volunteers Trail Maintenance Project

In partnership with Cycling Ulster and Outscape, the volunteer Trail Maintenance Project has gone from strength to strength, addressing complexities around the management of trail centre maintenance across Northern Ireland. Seven local authorities committed funding for staff training and volunteer costs were supported by the Outdoor Partnership and Cycling Ulster.

The project has taken a hands-on approach to support both councils and trail users in maintaining key sites. In April 2025, a four-day training programme was delivered at Davagh Trail Centre, equipping representatives from seven local authorities with trail maintenance, inspection, and supervision skills. Since then, coordinated dig days with volunteers and councils, particularly within the Sperrins trail centres Davagh, Gortin and Garvagh which have resulted in 78 volunteer hours to date, with further sessions planned in the coming weeks. The project has trained 14 trail inspectors, 14 maintenance coordinators, 10 land managers, and 19 volunteers, with 7 land managers on board across 7 trail centres, and a strong response of 126 volunteer applications.

All maintenance teams are now fully equipped with the necessary tools. Beyond the practical outcomes, the project has strengthened relationships between councils and trail users, fostered local ownership, and helped retain valuable skills within communities and local authorities. Trail maintenance is an ongoing process, and continued support is essential to sustain this successful, collaborative model into the future. 3.8 Youth Ambassador Project

In partnership with the Sperrins Partnership, The Outdoor Partnership has successfully launched the Sperrins Youth Ambassador Project, a 12-month outdoor education initiative aimed at youth aged 14-17 from across the Sperrins region. The programme is designed to empower young people by developing outdoor skills, environmental awareness, leadership, and fostering deep connections with the natural landscape.

To date, a diverse range of sessions have been delivered, including bushcraft skills, biodiversity and native species education, natural history and folklore, navigation and hill-skills, and a peatland restoration session in collaboration with Ulster Wildlife. The next session planned is a certified outdoor first aid course. Engagement has been strong with participants drawn from all corners of the Sperrins.

The outcomes thus far include enhanced skill sets among youth ambassadors, increased environmental stewardship, stronger community connections, and growing ownership of local landscapes. The programme is also helping to preserve traditional knowledge, boost confidence and leadership, and promote ongoing care for the Sperrin Area of Outstanding Natural Beauty. As we continue to develop and learn from this project, we hope in time it will build its own legacy for future participants to aspire to join.

3.9 General Delivery Update

Beyond our core trail-maintenance and youth ambassador programme, a suite of complementary delivery projects is underway across the Sperrins which includes the roll out of hill-skills training, delivery of International Women's Day outdoor sessions, and coach education for Advanced-affiliated TOP clubs. Mountain bike youth initiatives have been delivered at all three trail centres, including a successful "Ready to Race" youth event at Davagh Forest Park in partnership with Mid Ulster Council and Cycling Ulster, which attracted 40 youth riders aged 8 to 14.

In early 2025 TOP successfully delivered a host of rural community and Equality Diversity and Inclusion (EDI) initiatives in the Mid Ulster area through their Sport NI community planning application. A total of 16 activity sessions and 163 unique participants were engaged with through further coach education, disability sessions and community cohesion activities.

Building on the success of a previous Public Health Agency (PHA) "Clear" funding initiative with the Dennett Valley Health Care group, an application was resubmitted a 2025 to PHA to deliver a men's outdoor wellbeing project in Donemana. Delivery is scheduled to begin in the coming weeks. We aim to expand similar projects across other parts of the Sperrins in 2026 and will engage council community officers to inform the planning of future programmes.

3.10 Funding & Sustainability

To sustain delivery and operations across the Sperrins AONB, The Outdoor Partnership (TOP) remains committed to securing external funding. In 2025 we have successfully secured funding from Mid Ulster's Sport NI / Community Planning grants, two PHA awards, and currently have live applications for Peace+ "Change Makers" funding themes. Concurrently, TOP is actively participating in Sport NI's consultation exercises to identify possible revenue streams for future funding.

The Sperrins Partnership provides the delivery model to ensure the Management Plan can be achieved. Agreement was sought at this Committee in October 2024 to the following council contributions:
