## **1. THE MAYOR'S BUSINESS**

The Mayor congratulated everyone involved in the lighting of the Christmas Trees and lighting up the four main towns in the Borough.

The Mayor advised that the North West Regional College has received a prestigious award and invited Alderman Callan to provide further detail.

Alderman Callan stated that the North West Regional College received the Queen Elizabeth prize for education recognising the outstanding work in business support. Alderman Callan stated the Award was highly regarded, seen as the highest national award in Further and Higher Education within the UK. This award recognises the work the College has done over the last number of years. Alderman Callan stated staff were delighted that they had been announced as one of the winners for 2025 for the Queen Elizabeth Award.

## **4. DEPUTATION – NI WATER GAVIN MCCREADY, HEAD OF WASTEWATER SERVICES, CUSTOMER & OPERATIONS DIRECTORATE AND DR STEPHEN BLOCKWELL, HEAD OF INVESTMENT MANAGEMENT, ENGINEERING & SUSTAINABILITY DIRECTORATE IN ATTENDANCE**

The Mayor invited the representatives from NI Water to present to Members.

Dr Blockwell introduced himself and G McCready.

Dr Blockwell delivered a presentation to Members, covering the following topics:

- NI Water Governance Mode
- About NI Water and relevant statistics
- Challenges currently faced by NI Water
- What NI Water are doing to maximise resources

- Local Development Plan 2038
- Planning key capital investments in water and wastewater
- Kilrea wastewater treatment plan
- Price Controls
- Planned investment
- PC28 business plan timeline

In response to questions Dr Blockwell advised NI Water are taking a multi barrier approach to the algae bloom which occurred in the summer. Dr Blockwell advised that water was safe to drink, NI Water work to maintain and improve their assets and that water was treated to the set standards. Dr Blockwell stated the main problem was getting the funding required to put the solutions in place.

In response to questions regarding upgrading the Wastewater treatment in Armoy Dr Blockwell advised he was aware of the concerns. Dr Blockwell stated the answer lies with the politicians and that if NI Water was fully funded they would have the resources required to put in place. Dr Blockwell stated that Armoy was included in the PC 28 process.

G McCready stated that NI Water were working hard to meet standards and to stay as efficient and effective as possible.

In response to questions regarding working with developers to provide solutions for funding from outside the NI Executive, Dr Blockwell stated that discussions were being undertaken with the Department for Infrastructure to find these solutions.

In response to questions regarding having capacity to facilitate the housing growth that was required within the Borough, Dr Blockwell stated that NI Water were putting effort into their plans to address this. Dr Blockwell stated that the focus is on having the basic infrastructure in place and building on that. Dr Blockwell stated that NI Water were focused on working at full capacity and abiding by licences in place to protect the environment.

In response to questions regarding the adoption of sewage systems and services, Dr Blockwell stated that checks are completed and if the works are up to standard they are adopted. In instances where systems are not adopted, extra funding is required, this normally is centrally funded from the Department for Infrastructure, although, he stated, there was some funding from PeacePlus projects that have been received from cross border funding. Dr Blockwell stated that although there are bonds in place these are often not enough as these can be used on completing roads and pavements. Dr Blockwell confirmed that he would provide

further information regarding increasing bonds directly to Alderman McAuley who had made the enquiry.

G McCready stated that NI Water did their best to assist people in sites where adoption of the sewage system has not been completed.

In response to questions, Dr Blockwell stated there are approximately 19,000 homes which have been unable to proceed due sewage connections not being installed and confirmed the housing that had been stalled as a result of this had been prioritised.

The Mayor thanked Dr Blockwell and G McCready for their presentation.

The purpose of the report is to present correspondence for Members' consideration.

### **13.1 Joseph McGuckin, Mid Ulster District Council** (email dated 3 November 2025, copy of letter attached)

Re: Caoimhé's Law

*Council at its October meeting carried the undernoted motion:*

*That this Council expresses its deepest sympathy to the families affected by the unauthorised recording, sharing, and circulation of images and videos taken at the scenes of fatal or critical road traffic collisions. Condemns the increasing trend of individuals and media outlets capturing and distributing distressing footage of victims without consent, often before families have been formally notified. Recognises the serious psychological harm and trauma this causes to bereaved families, and the urgent need for legislative protection. Reaffirms that the right of families to privacy and dignity must always outweigh the voyeuristic or commercial interests of individuals or media outlets.*

*Backs the campaign for Caoimhé's Law — a proposed piece of legislation that would make it a criminal offence to:*

- *record or share images/videos of victims at the scene of a fatal or critical road traffic collision without lawful authority or family consent;*
- *circulate such material before families are officially notified;*
- *use such content for sensationalist, exploitative, or commercial purposes;*
- *publish crash scene images without prior approval from the PSNI or relevant authorities;*
- *obstruct emergency services or interfere with rescue operations through the recording or sharing of such material.*

*Acknowledges the testimony of families, including those from this district, who have been directly impacted by the unauthorised sharing of videos and images of their loved ones in the immediate aftermath of fatal road incidents. Notes that similar legislation exists or is being introduced in other jurisdictions, including the Republic of Ireland and England & Wales, recognising the same growing problem of “digital voyeurism” at accident scenes.*

*Calls on the Northern Ireland Executive and the Department of Justice to prioritise the drafting and introduction of this legislation as a matter of urgency.*

*I would therefore ask if you would bring this request to your elected Members for consideration and support. I would also welcome a response to this request so that I can report back to our Members in due course. ### **13.2 John Kelpie, Chief Executive, Derry City and Strabane District Council**

*(email dated 14 November 2025, copy of letter attached)*

*Re: Caoimhé’s Law*

*At meetings of Derry City and Strabane District Council held on 24 September 2025 and 29 October 2025, the following Motion was passed:*

*That this Council expresses its deepest sympathy to the families affected by the unauthorised recording, searching, and circulation of images and videos taken at the scenes of fatal or critical road traffic collisions.*

*Condemns the increasing trend of individuals and media outlets capturing and distributing distressing footage of victims without consent, often before families have been formally notified.*

*Recognises the serious psychological harm and trauma this causes to bereaved families, and the urgent need for legislative protection.*

*Backs the campaign for Caoimhe’s Law - a proposed piece of legislation that would make it a criminal offence to:*

- *Record or share images/videos of victims at the scene of a fatal or critical road traffic collision without lawful authority or family consent;*
- *Circulate such material before families are officially notified;*
- *Use such content for sensationalist, exploitative, or commercial purposes;*
- *Publish crash scene images without prior approval from the PSNI or relevant authorities.*

*Acknowledges the testimony of families, including those from this district, who have been directly impacted by the unauthorised sharing of videos and images of their loved ones in the immediate aftermath of fatal road traffic accidents. Calls on the Northern Ireland Executive and the Department of Justice to prioritise the drafting and introduction of this legislation as a matter of urgency.*

*Agrees to write to the Minister for Justice, local MLA's, and the Secretary of State for Northern Ireland to formally convey the Council's support for Caoimhe's Law.*

*Recognising the all-island nature of road traffic and digital media sharing, this Council also calls for cross-jurisdictional cooperation between the Department of Justice in Northern Ireland and the Department of Justice in the Republic of Ireland in developing compatible legislation.*

*Further calls on digital and social media companies to work with law enforcement and legislators to rapidly remove unauthorised and harmful content relating to fatal incidents.*

*Encourages media outlets operating within the Council area to adopt and adhere to ethical guidelines that prohibit the publication of images or footage from fatal or critical incidents without clearance from authorities and consent from families.*

*Requests that the Council's Communications and Community Safety teams explore ways to raise awareness locally about the legal and emotional consequences of sharing such content, particularly among young people and frequent social media users.*

*Caoimhe's Law has been proposed in response to a growing number of cases where families are retraumatised after graphic videos and images of their loved ones are shared without consent. The law is not about censorship but about ensuring basic dignity and accountability.*

*Council support can play a crucial role in influencing legislative attention and amplifying public education around this issue.*

*Council will:*

- *Write to all 10 Councils that all council areas across Northern Ireland enforce and endorse this campaign, and that they fully utilise their social media platforms to promote awareness of the issues addressed by Caoimhe's Law.*
- *Requests the opportunity for campaign representatives to present directly to the relevant Council committee to share personal testimonies and further outline the case for legislative change.*
- *Further requests that the Minister for Infrastructure bring forward and draft specific legislation to criminalise the unauthorised recording and sharing of images from fatal and serious road traffic collisions.*

*I would appreciate your consideration in this important matter and would be grateful for a response at your earliest opportunity.*

**13.3 Richard Pengelly CB, Chief Executive, Education Authority** (email dated 20 November 2025, copy of letter attached)

**Buddy Bear Trust**

I refer to your letter dated 28 October 2025 regarding Buddy Bear Trust. At present we are funding placements for less than 5 pupils and not all would be full time. These placements are named on the pupil statement either as an agreement by EA to do so as they are appropriate placements or as a result of a SENDIST order.

Should schools wish to apply for additional funding from the Department of Education (DE) to expand provision, they are required to submit a formal application outlining the proposed expansion, anticipated outcomes, and supporting evidence of need. Applications should be made directly to DE via their online portal or by contacting the relevant department and must include detailed costings and a strategic plan for implementation. Once submitted, applications will be reviewed and assessed in line with DE criteria, with decisions communicated to the school in due course.

## **16. NOTICE OF MOTION PROPOSED BY COUNCILLOR ALLISTER KYLE, SECONDED BY COUNCILLOR JONATHAN MCAULEY**

*I hereby move that Causeway Coast and Glens Borough Council support the proposal to rename Riverside Park in Dervock to McKinley Park in memory of the 25th President of the United States, William McKinley, and to commemorate the deep ancestral ties between Dervock and the McKinley family.*

*As we know year 2026 marks the 250th anniversary of the signing of the Declaration of Independence in the United States, a momentous event that laid the foundation for the nation's freedom and democracy. In recognition of this anniversary and taking into account we have set up a committee to oversee the*

*anniversary, we believe it is fitting that we reflect on the profound historical connections between the North Antrim village and the United States.*

*Dervock's primary link to the Americas lies in its ancestral connection to William McKinley, the 25th President of the United States. McKinley's great-great-grandfather, James McKinley, who emigrated from the townland of Conagher, near Dervock, in 1743. This historic connection offers a unique opportunity to honour Dervock's contribution to American history and heritage.*

*The renaming of Riverside Park to McKinley Park would serve as a lasting tribute to the legacy of William McKinley, highlighting the role that Dervock's local heritage has played in shaping American history. This renaming would not only honour McKinley's presidential legacy but also strengthen the bond between the town and its American roots.*

*By renaming the park, the council would help raise awareness of this important historical link, fostering a greater understanding of the global influence of the Causeway Coast and Glens region. This gesture could also encourage cultural exchanges and promote tourism, with an emphasis on the rich historical ties between the US and Dervock.*

*I recommend that the Council formally approve the proposal to rename Riverside Park in Dervock to McKinley Park, in commemoration of the 250th anniversary of the signing of the Declaration of Independence and in recognition of the ancestral connection between Dervock and President William McKinley.*

*This renaming would serve as a lasting tribute to both the McKinley family and the history of the United States, while also promoting local heritage, education, and international ties between Dervock and the United States.*
