1. THE MAYOR'S BUSINESS

The Mayor stated that she attended Millburn Primary School prize giving day and a Volunteers Week event in the Lodge Hotel today. The Mayor stated that she will be attending an event in Ballymoney on Wednesday and in Ballycastle on Thursday.

2. APOLOGIES

Apologies were recorded for Alderman Callan, Alderman Scott, Councillor McGlinchey, Councillor McMullan, Councillor Nicholl, Councillor Watson, and Councillor Wilson.

Councillor Peacock expressed condolences to Councillor McMullan on the sad passing of his granddaughter.

The Mayor expressed condolences to Councillor McMullan on the sad passing of his granddaughter. This was echoed by all Members, with Councillor Callaghan speaking on behalf of the DUP, Alderman Coyle on behalf of the SLDP, Councillor Kyle on behalf of the TUV, Councillor Kane on behalf of the Alliance Party, Councillor Holmes on behalf of the UUP, Councillor Watton on behalf of the PUP and Councillor MA McKillop all expressing their sincerest condolences to Councillor McMullan on the sad passing of his granddaughter.

Councillor Kyle stated that the TUV were not present at the Annual Meeting and gave his congratulations to the Mayor and Deputy Mayor in their new role.

5. MINUTES OF ENVIRONMENTAL SERVICES COMMITTEE MEETING HELD TUESDAY 12 MAY 2026

Matters Arising

5.1 Festive Light Proposal 2026 (Item 6)

Councillor Bateson expressed disagreement regarding how hamlets have been defined. He stated that Glenullin has a wide outlying area and that it contains several community facilities such as a shop, GAA club and Chapel. He stated that Glenullin have been trying to get a Christmas tree for a number of years and that they do not have connection to the main electricity supply for the Christmas lighting and this connection is required. Councillor Bateson stated that on the night of the Environmental Services Committee his proposal was for Glenullin to be included in the large hamlet category so they can have a metal tree installed. Councillor Bateson referred to Ballintoy also being placed in the small hamlet category and how they will no longer be receiving a Christmas tree from Council.

Proposed by Councillor Bateson

Seconded by Councillor C Archibald

- That Glenullin and Ballintoy are included in the large hamlet category in order to be provided with a Council Christmas tree

Alderman McAuley stated that the criteria to define settlements needs to be consistent across the Borough and queried what the precedent would be if the criteria was changed.

In response to the query from Alderman McAuley the Director of Environmental Services stated that the statistics used were taken from the NISRA 2022 population table which shows a clear distinction in the population for each settlement category.

Councillor McAuley stated that at the Environmental Services Committee he had requested going back to coloured lights on the Christmas trees. Councillor McAuley stated he was raising this as a matter of accuracy as this is not included in the Environmental Services Committee minutes.

Councillor McShane supported comments made by Councillor Bateson. She further stated that Ballintoy has a large hinterland and contains community facilities such as a Church of Ireland, a Catholic Church, an Orange Hall, a Gospel Hall, a Masonic Hall, and holiday accommodation. Councillor McShane stated that the Christmas tree is something villages rally around and it creates a sense of community spirit.

Councillor Chivers stated that members of the Limavady Town Centre Forum expressed interest in having a metal tree and queried how the decision was made for all the large towns to have a traditional tree.

The Director of Environmental Services stated that the 6 large towns were defined as having 5000+ residents, that Members had decided that large towns would be provided with a traditional Christmas tree and that Members can amend this decision if they wish.

Councillor Chivers made a proposal that Council engage with the Town Centre Forums to ascertain which type of Christmas tree they would prefer.

Further discussion ensued regarding the definition of settlement categories and the analytical tools that can be used to provide these definitions, engaging with Town Centre Forums and community groups in the larger towns regarding what type of Christmas trees they wish to have, ensuring that settlements across the Borough are treated fairly and the timeframe required to make a decision.

Alderman S McKillop proposed that the item is referred to the Environmental Services Committee for further discussion.

In response to questions the Director of Environmental Services stated that community groups were consulted in hamlets and villages and that it was clear that traditional trees were being provided for the large towns including Portrush and Portstewart.

Councillor Bateson stated he wanted to change his amendment so that the original proposal stands, with the categorisation of hamlets being reconsidered and consultation with the large towns regarding which Christmas tree they wish to have.

Alderman McAuley proposed that the original proposal made at the Environmental Services Committee remains as it is with the caveat that Officers provide a report with reconsideration of how hamlets are categorised and that large towns are given options for their Christmas tree as a separate proposal.

Councillor Bateson agreed to amend his proposal to include large towns and at the request of the Mayor Councillor Bateson stated his amendment:

- That the categorisation of hamlets is reconsidered by the Environmental Services Committee as soon as possible, that large towns are consulted on the options for their Christmas tree and that the remainder of the Committee recommendation remains the same

The Mayor put the motion to the vote

RECRUITMENT OF INDEPENDENT MEMBERS TO THE POLICING BOARD

The term of office for a number of independent members of the Policing Board is scheduled to end shortly. I intend to launch a recruitment competition in the near future in order to fill these vacancies. The Policing Board plays a critically important statutory role in ensuring that an effective and efficient police service is in place. The Board is also tasked with bringing stability to, and instilling confidence in, the PSNI.

In accordance with Schedule 1, s.8(2) of the Police (Northern Ireland) Act 2000, and before making any appointments to the Board under s.6(1)(b) of the Act, there is a statutory requirement for the Justice Minister to consult:

- a) the First Minister and deputy First Minister;*
- b) district councils; and*
- c) such other bodies as considered appropriate.*

It is imperative that appropriate appointments are made to the Policing Board to ensure that it has the required knowledge, skills and experience in providing independent oversight of policing in Northern Ireland and holding the Police Service of Northern Ireland to account on behalf of the public. It is envisaged that the criteria for the recruitment competition will likely include a need for candidates to demonstrate abilities in:

- Managing and Influencing Relationships;*
- Strategic Focus;*

- *Corporate Governance and Organisational Performance; and*
- *Organisational Leadership.*

In seeking to appoint independent members to the Board, I am committed to the principles of public appointments being made on merit, with independent assessment, openness and transparency at the heart of that process. The recruitment competition and appointment process will be regulated by the Commissioner for Public Appointments for Northern Ireland.

If you wish to provide any comments in respect of the matter, I would be grateful if you could do so within 2 weeks of the date of this letter.

We are writing to formally request that Causeway Coast and Glens Borough Council confer the Freedom of the Borough upon Coleraine Football Club. This is in recognition of their outstanding contribution to the Borough, its sporting excellence and profound cultural and community impact, particularly in light of the club's 100th anniversary in 2027.

Founded in 1927, Coleraine Football Club, has for nearly a century stood as one of Northern Ireland's most respected and successful sporting institutions. Throughout its history, the club has represented the town and the wider Borough with distinction at regional, national and European levels, bringing positive recognition to Coleraine and inspiring pride across generations. Beyond the pitch, Coleraine FC has long been a cornerstone of community life within the Borough. It has played a vital role in promoting youth engagement, through grassroots programmes, encouraged inclusion, wellbeing, and cross community participation through sport. All this whilst supporting schools, charities, and community initiatives. The upcoming centenary year of 2027 represents an historic milestone, not just for Coleraine FC, but for the Borough itself. Conferring the Freedom of the Borough at this time would be a fitting and enduring tribute to a club that has faithfully served its community for 100 years, and continues to do so with integrity, ambition and respect and have rendered exceptional and sustained service to the area.

Few organisations embody this principle more fully than Coleraine Football Club. Freedom of the Borough would not only honour the club's remarkable past but would stand as a powerful symbol of the Borough's appreciation for the role sport plays in shaping unity and pride within our community.
