Council staff worked hard to ready Coleraine for the arrival of the Royal Horticultural Society (RHS) from the Britain in Bloom campaign ahead of the RHS Judges' arrival on Thursday 11th August 2016.

The Heart of the Glens Festival, in Cushendall, is one of the most successful community festivals in Northern Ireland and ran again this year from 6th to 14th August. This year the festival celebrated 25 years of the 'Lurig Run'.

The River Bann played host to Waterways Ireland Riverfest and the 2016 European and African Wakeboard Championships which took place 8th-13th August 2016. This was the very first year that the European and African Wakeboarding Championships have been combined with the main Waterways Ireland Riverfest event.

Stendhal Festival of Art took place on the 12th and 13th of August was a huge success with around 5000 visitors attending the two day festival in Limavady.

Causeway Market hosted a special 'food only market' in Coleraine at the weekend (Saturday 20th August) to celebrate the NI Year of Food and Drink, with three of our Councillors taking part in the 'Can't Cook, Won't Cook'.

The Pipers returned to Portrush for the North West Pipe Band & Drum Major Championships 2016 on Saturday 20th of August. I was also acting as Chieftain of the Gathering.
