4 PRESENTATION – NORTHERN IRELAND HOUSING EXECUTIVE: CAUSEWAY COAST AND GLENS, HOUSING INVESTMENT PLAN

The Mayor welcomed Paul Isherwood, Director of Asset Management and Frank O'Conner, Regional Director North, Northern Ireland Housing Executive to the meeting.

Council was advised that the New Housing Investment Plan (HIP) replaced the District Housing Plans. This was due to change in statutorily requirements to report to councils on past years performance and next year's proposals, plus the Housing Executive is a Community Planning Partner and the HIP provides an evidence base that will inform Community Planning.

The HIP provides an overview of the housing market in the Causeway Coast and Glens Borough Council area; examines cross tenure housing issues and detailed social housing investment at a local level; is a 4 year plan with an annual update in intervening years and in future years will be reviewed to reflect Community Planning priorities.

The HIP contains 5 themes, 10 outcomes and tables show last year's performance against plans and actions for the next 2 years and longer term outlook.

Members were given an update on Housing Executive Investment in Causeway Coast & Glens area; key housing issues which included statistics on aging population; homeless; growing waiting lists and social housing allocations in 2016/17.

The HIP will be regularly monitored again objectives and report to Council annually.

The following points were made:

- Housing Investment grants were set in legislation and had been reduced by the Assembly by 5%.
- The Housing Executive follow up on reports of ghost tenants and bins are checked to ascertain if tenants are living in properties.
- The Housing Executive had terminals in place in local offices to help with implementation of Universal Credit.

The representatives from the Housing Executive were thanked for presenting to Council and for the excellent HIP Clinic held prior to the meeting.

Councillor Mulholland reiterated concerns he had raised at the Leisure & Development Committee Meeting and suggested that there should be a fund created that is limited per annum for events

Alderman Hickey suggested now that the motion had been widened out that the Notice of Motion be brought back to the Leisure & Development Committee to re discuss with facts and figures.

The Mayor put the amendment to the meeting, with 18 voting for, 8 against and 5 abstentions. The Mayor declared the amendment carried.

The Mayor queried if Alderman Hickey wished to make her suggestion formal by it being seconded and put to a vote.

Proposed by Alderman Hickey Seconded by Councillor Loftus that

'Considering the implications of the amendment, the Notice of Motion should be brought back to the Leisure & Development Committee for further discussion when facts about what Council was being asked to do were available.'

The Mayor put the proposal to the meeting, with 7 Members voting for, 15 against and 2 abstentions. The Mayor declared the proposal lost.

The Chief Executive advised that a Working Group would be set up to look at the matter and progress details of the Notice of Motion.
