1 APOLOGIES

Apologies were recorded from Alderman Campbell

2 DECLARATIONS OF INTEREST

None.

3 DEPUTATION – GLENS ANGLING CLUB

The Chair welcomed David Rae, Hugo McCormick and James McKillop, Glens Angling Club to the meeting.

It was highlighted to the Committee that the main threat to the wild salmon stocks along the coast was sea lice emanating from salmon farms which act as a reservoir for lice production. The lice attack the flesh and protective mucus of the fish, leaving it wide open to infection until it dies, hence, the smolt never make it to the North Atlantic feeding grounds to grow and return to natal river in Ireland or Scotland.

The Deputation quotes scientific facts on the decline of the salmon which were now well below safe conservation and self-sustainable limits resulting in a total ban on coastal netting of wild fish. It was also quoted that incidents of farmed salmon escaping from cages resulted in Glenarm wild stock being comprised and genetically changed and a follow up test 7 years later revealed that the wild population was to some degree genetically different from the pre-escape population.

In conclusion, the Deputation stated that the new Minister should be put in the picture with regard to protection of indigenous fish stocks and that:

- the Scottish, Irish and local administration at Stormont needed to be challenged to the damage from fish farms within their jurisdictions;
- all escaped farmed salmon must be destroyed and disposed of properly;
- the feasibility of removing salmon cages from sea lochs and estuarine areas
 to onshore closed containment facilities should be further explored given
 that pilot plants have already been established and found to work effectively
 in Scotland and Canada.

12.9 LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) (NI) ORDER 1987

ARTICLES 13 & 14 - BYE-LAW FOR THE BUSINESS OF COSMETIC PIERCING

The above Bye-law requires any person who wishes to carry on the business of cosmetic piercing to register themselves and their premises and to observe the Bye-law relating to the cleanliness and hygiene of premises, practitioners and equipment to protect customers against the risk of infection.

The premises has been inspected by an officer from the Department and found to comply with the requirements and a certificate has been issued accordingly.

In accordance with Standing Orders 12(o) Councillor Chivers requested the following information:

The cost of cleaning up after 11th night bonfires

Response: Not all clean-up costs are currently available. A report will be brought back to the next Environmental Services Meeting.

 How many complaints or reports did council receive and what action was taken?

Response: 25 complaints were received, an increase from previous years. Actions included investigation on each complaint and if Council would do anything, this was carried out. For example lifting of materials.

 How many bonfires were on council property if any bonfire were on council property and there was burning of illegal properties eg tyres etc and will there also be enforcement steps taking to hold people/organisations to account?

8 out of 29 bonfires in the Borough were on Council property, with many having tyres placed on them, although the number of tyres were reduced from previous years. If Council has evidence, enforcement steps will be taken. A report will be brought back to Environmental Services Committee with additional information on work carried out with organisations to make bonfires safer and to comply with legislation.

During the discussion it was highlighted that often complainants about bonfires were reluctant to make an official statement which was needed for enforcement action and the role NIEA played in enforcement was called into question.

The work carried out by Elected Members and Officers in taking the lead to prevent tyres being used on bonfires was commended.

Proposed by Councillor Baird Seconded by Councillor Holmes and

AGREED – that Council would write to NIEA on use of tyres on bonfires and the role of NIEA in enforcement.

The Director of Environmental Services agreed to follow up on a request to have pathways cleared at river paths in Cushendall and Waterfoot.

AGREED – that the burning of tyres on bonfires and lack of information sharing between Departments to identify those responsible for tyre use on bonfires to be brought to the attention of the Partnership Panel.

15 PROVISION FOR THE SERVICES OF THE HAULAGE, TREATMENT, RECYCLING AND DISPOSAL OF NWRWMG COLLECTED LOCAL AUTHORITY STREET SWEEPING AND GULLY WASTE

The Committee received a report to advise that an procurement exercise had been carried out for the provision for the services of the haulage, treatment, recycling and disposal of NWRWMG collected local authority street sweeping and gully waste.

The initial contract period will be for 24 months, however, this may be extended at the sole discretion of the council by a further 12 months.

Two tender responses were received, with one potential provider submitting a compliant tender. The Joint Committee of NWRWMG has recommended that Council consider the selection of ReCon Waste Management Ltd.

Proposed by Councillor Duddy Seconded by Councillor McCaul and

AGREED – as recommended, that Council approves the recommendation made by the Joint Committee of NWRWMG and award the tender to ReCon Waste Ltd.

16 PROCUREMENT OF 2 NO. 7.5 TONNE TIPPER CAGE LORRIES

The Environmental Services Committee received a report outlining that Council require a range of vehicles to assist in the delivery of the waste collection and street cleansing functions.

Two 7.5 tonne tipper cage lorries are in need of replacement, namely a 1997 lveco tipper (Coleraine depot) and a 2005 MAN tipper (Ballycastle depot). Vehicles requiring replacement are unreliable and inefficient. The proposed replacement vehicles are more efficient, economical and environmentally friendly, both having Euro 6 engines.

It is essential that Council operate a fleet of vehicles that are efficient and meet current environmental and legislative standards.

Council tendered for 2 no. 7.5 tonne tipper cage lorries. Four tenders were received by the agreed deadline. All tenders received were compliant. Lowest tender price received was from J&F Group, Mallusk Road, Newtownabbey.

Proposed by Councillor Duddy Seconded by Councillor Holmes and

AGREED – as recommended that Council purchase 2 no. 7.5 tonne tipper cage lorries from J&F Group, Mallusk Road, Newtownabbey at a cost of £35,440.
