Re: Planning Application LA01/2023/1164/F – Realignment of Existing Laneway at Drumack Hollow, Rasharkin

We note that the above application has now been listed for refusal. Upon reviewing the case officer's report, it is evident that the position remains unchanged despite a site visit and meeting, during which the planning officer accepted several key facts regarding the site and its surrounding development.

During this meeting, it was acknowledged that the area in and around Drumack Hollow is of a suburban character, that the laneway serves as a shared access, and that its realignment is essential for the dwellings located along its length.

Furthermore, previous case officer reports and supporting information provided by Manor Architects consistently reinforced the following:

- There are no key vantage points that would be negatively impacted.
- The site and surrounding lands integrate well within the existing landscape.
- No detrimental impact on the countryside would result from the proposed works.
