Dear Councillor,

As a concerned resident of the Causeway Coast and Glens, we are requesting you protect and defend the interests of local people and PRESERVE our natural environment by halting the proposed wind farm at Banagher Glen. It is interesting to note that despite the prevalence of wind farms in this area customers do not benefit from reduced energy bills. As a resident of Carnanbane, I am deeply troubled about the future of our wee safe place. Many of us – myself included – have been losing sleep, along with our vulnerable neighbours, because of the fear and uncertainty facing our community. We don't use email or modern technology, and that makes us easy to prey upon and easy to ignore.

Our area already receives so little, and the only real blessing we have is the glen – a place where people find peace and wellbeing, and where the birds and animals thrive. Now even that is under threat of being destroyed. If this happens, it will take a devastating toll on people's mental health.

Children here already face hardship. There is no secondary school bus, meaning they must walk along the Carnanbane and Banagher roads just to catch one. These roads are dangerous – too narrow for two vehicles to pass safely – and yet they are to be used for transporting massive wind turbines. In winter, the roads are left unsalted, but they will no doubt be prioritised to serve industry, while local needs continue to be neglected.

These children, and our community as a whole, have already suffered more than enough. The farmers behind this plan have no dependents and no real care for the people who actually live here. Right now, Carnanbane has become a very frightening place for ordinary families and neighbours.

We are calling out in desperation for this to be heard before our community, our wellbeing, and our safe place are lost forever.
