The purpose of this report is to update members on progress on this project since it was last considered at the September Leisure and Development Committee meeting.

Background

At the Committee meeting on the 12th September, Members received a report and presentation recommending the development of business cases to evaluate the options relating to a number of leisure projects for the town of Portrush.

This report recommended that Members approve:

- 1. The proposed objectives for the leisure and recreation projects for Portrush.
- 2. That officers proceed to outline business case appraisals for the 3 projects as follows:

1.	Outdoor Recreation, formal and informal.	Ramore Head Recreation Grounds.	 1 or 2 Bowling Greens. 3 or 4 tennis courts. Small play facility. Small urban sport features. New pavilion. Green/Event space. Pay and display parking. Adventure play.
2.	Integrated Play Facility.	The Bowl or Dunluce/Metropole.	The main site for: Urban Sport. MUGA. Play.
3.	Training pitch/small sided games.	Parker Avenue or Glenmanus.	Synthetic training areas for pitch based sports for formal bookings.

Having considered the paper and the recommendations, Members asked officers to convene a Member/Stakeholder workshop where relevant stakeholder groups would be invited to present an account of their needs and aspirations to the Councillors and to make themselves available to answer questions.
