#### 1.0 Background

The 'Protocol for the Operation of the Planning Committee' sets out the requirement to provide monthly updates on the number of planning applications received and decided.

#### 2.0 Details

- **2.1** Annex 1 and 2 provide a list of planning applications received and decided respectively by Causeway Coast and Glens Borough Council in the month of September.
- **2.2** Table 1 below details the number of planning applications received by delegated or nondelegated application category. Although all applications received in the month of September were local applications, it is important to note, however, that there may be a number of those applications that, during the processing of the application, may change to the Planning Committee non-delegated category as a result of the criteria set out in Part B of the Scheme of Delegation, e.g. objections from more than 5 separate addresses being received to the proposed development or referred applications.

2.3 As is evident from Table 1, the number of applications received in September has increased by 14% when compared to the previous month. Overall, when compared with Quarter 1 (April - June), the number of applications received in Quarter 2 (July – September) has increased by 1% (295 applications). The potential reason for the low numbers of major applications received is likely due to the requirement to notify the planning authority of the intention to submit a major application at least 12 weeks in advance of submission - Pre-Application Notice (PAN) - from 1<sup>st</sup> July 2015.

- **2.4** Table 2 below details the number of planning application decisions that issued in the month of September by Delegated decision or Non-Delegated decision and compares this with Quarter 1, July and August.
- **2.5** The number of decisions issued has again risen. In comparison to Quarter 1 (April June), the number of decisions issued in Quarter 2 (July August) has increased by over 10% (256 decisions).
