1.0 Background

The 'Protocol for the Operation of the Planning Committee' sets out the requirement to provide monthly updates on the number of planning applications received and decided.

2.0 Details

- 2.1 Annex 1 and 2 provide a list of planning applications received and decided respectively by Causeway Coast and Glens Borough Council in the month of March. Please note these exclude Pre-Application Discussions; Certificates of Lawful Development Proposed or Existing; Discharge of Conditions and Non-Material Changes, to correspond with official validated statistics published by DoE.
- 2.2 Table 1 below details the number of planning applications received and decided as well as the number of live planning applications in the system and those in the system over 12months. Please note that only Q1 are validated statistics and all other statistics are extracted from internal management reports and are unvalidated.

- 2.3 As is evident from Table 1, the number of applications received Quarterly continues to remain above the 300 mark. Ten Certificate of Lawful Use Existing/Proposed (CLUDs) and 16 Pre-Application Discussions (PADs) were also received in Q4.
- 2.4 The number of decisions issued in Q4 also remains high with a further 4 Non-Material Change applications (NMC), 13 Discharge of Conditions, 11 Certificates of Lawful Use Proposed/Existing (CLUDs) and 4 Pre-Application Notices also issued during this period.
- 2.5 Although the number of applications in the system has decreased in Q4 the number of applications in the system over 12 months has continued to increase. Therefore an Action Plan is being put in place to address the applications in the system over 12months and bring them to a conclusion. This Action Plan is set out in Appendix 3.
- 2.6 Table 2 below details the number of referral requests received from elected members under Part B of the Scheme of Delegation. 50% of referred applications determined by the Planning Committee to date have had the recommendation overturned in favour of approving those applications. Two of the referred applications are to be determined by the Planning Committee at the 23rd March 2016 meeting with the date for the further 14 referrals yet to be confirmed.

APPLICATIONS OVER 12 MONTHS OLD – ACTION PLAN

PURPOSE

1. This Action Plan is being put in place in order to assist in improving customer service by brining to a conclusion those older application that have been in the system over 12 months.

PERFORMANCE

- 2. On 07 March 2016 there were 109 live applications over 12 months old. The number of applications in this category has increased over recent months. This highlights the need for action to resolve this issue.
- 3. By separating out the applications dealt with by the Enforcement, Minerals, Waste and Wind Farm (EMWWF) team, there is a remainder of 100 applications. By DEA grouping, these are distributed as follows:

- 4. This analysis shows that Limavady & Benbradagh DEAs have the highest number of applications over 12 months old. Given that overall the number of applications received in this DEA grouping is lower than that in Coleraine, Causeway and Bann DEAs, this indicates potential for improvement.
- 5. The majority of the applications over 12 months old are classified as Local in the current classification system. Therefore disaggregating the applications between local and major is not going to achieve much for the purpose of this exercise.
- 6. To provide more insight into the nature of applications over 12 months old, the applications have been categorised into the 2 categories "minor" and

- "complex". This typology looks only at the application description and does not analyse the specific circumstances of each case.
- 7. Applications classified as "minor" for the purpose of this exercise includes for example: house extensions; single dwellings and; small housing schemes. Applications classified as "complex" for the purpose of this exercise includes for example: renewable energy proposals; larger housing schemes; commercial development and; tourist schemes. Using this typology, there are 40 minor applications and 69 complex applications. Of note, of the 69 complex applications, 26 (38%) are for renewable energy proposals. By DEA grouping, these are distributed as follows:

8. The analysis shows that in all DEAs there are more complex applications over 12 months old than minor applications. This is to be expected given the nature of issues arising from such complex applications. However, an anomaly is indicated for Limavady & Benbradagh DEAs which shows that the number of minor applications is much higher than the other DEA groupings.

MONITORING AND REPORTING

- 9. The Action plan focuses on a number of short-term actions that are required by all teams in order to reduce the number of over 12 month applications in the system by 50% over the next business year.
- 10. Progressing minor applications potentially offers the greatest opportunity for improvement given that the issues are generally less difficult (and time consuming) than those in the complex typology. A suitable target is a reduction in the number of these minor applications by 75% within 6 months.
- 11. Progressing the complex applications is more problematic given the nature of the issues arising. However, there is an evident need to reduce the number within this category. A suitable target is a reduction in the number of these complex applications by 30% within 6 months.
- 12. Reduction of over 12 month application overall by 50% to no more than 55 application by 1 April 2017.

13. Achievement of this target through use of staff resources will be managed by the respective Senior Planning Officers for the respective DEA groupings. A report on progress will be required on a quarterly basis to confirm progress and identify any issues that need to be addressed.
