1.0 Background

- 1.1 Fermanagh and Omagh District Council published its Local Development Plan 'Preferred Options Paper' (POP) for public consultation on 3rd October 2016.
- 1.2 The POP provides the basis for consulting with the public and stakeholders on a series of options for dealing with key issues in the Fermanagh & Omagh plan area. It aims to stimulate public comment and help interested parties to become involved in a more meaningful way at this earliest stage of plan preparation.
- 1.3 Effective community and stakeholder engagement also strengthens the evidence base for plans and strategies which in turn, is used to inform the preparation and help justify the 'soundness' of the local development plan.
