We support the development of dynamic research to consider the viability of intervention: Council + Newry & Mourne City Council + Strabane

(i) Legislative regulation of retailers for milk supplier and consumer protection such as that which prevails in other EU nations, and Council + North Down Borough Council + Moyle Dist

(ii) Price banding to provide commodity security for dairy farms together with the fair and transparent transfer of any resulting benefits to farmers."

I look forward to your Council's response as soon as possible in view of the all Council, a District Co socio- economic importance of this matter.

NILGA's Rural Development Working Group will convene in August and take cognisance of le District Cou the views of all responding local authorities.
