<u>Consultation Acknowledgement, RBL Bennet House - proposed</u> closure

Thank you for contacting us with Council's response to the proposed closure of the Legion's Break Centre, Bennet House, in Portrush. The views of our staff, external stakeholders and the Armed Forces community are important to us as we do not work in isolation and we recognise that serving personnel, veterans and their families deserve the very best support from us.

As you will no doubt be aware, the Legion has for nearly a century supported the Armed Forces community through the provision of comradeship, practical help and campaigning on their behalf. As we look ahead to our centenary in 2021, we are exploring how best we can continue to meet the needs of a changing Armed Forces community and remain both relevant and fit for purpose to support our people for the next one hundred years.

As I'm sure you can appreciate, the Legion must uphold its charitable responsibilities to provide high quality services that support the Armed Forces community, and use the generous donations given to us by the public in the most impactful way. As part of our recent review of our services, we were therefore mindful about investing in activities that make the greatest contribution to improving the lives of those we serve.

The needs of the Armed Forces community are becoming increasingly complex. We are experiencing more demand for support, individuals often present with multiple needs such as both financial support and housing, and the cost of supporting each case has increased by an average of over 45% since 2016. In order to adapt to the changing landscape, we are proposing to invest in our personalised services and case work, bolster our collaborative working with local organisations, and strengthen the way

in which we provide care services to older veterans, who constitute a large proportion of the Armed Forces community.

To enable these changes, we will need to refocus our funding and make some difficult decisions, but always with the best interests of our community in mind. That is why we are discussing proposals to close our Handy Van Services in England and Wales, and our Break Centres across the UK, with potentially affected staff. I would like to stress that no final decisions have been made and that our consultation with staff is expected to last until early 2020, when a final decision will be announced.

I hope the above is helpful, and thank you once again for sharing your thoughts with us.
