## 1.0 <u>Purpose of Report</u>

To provide members with information regarding the appointment process for independent members of the Policing & Community Safety Partnership (PCSP) and to nominate additional panel members comprising of up to three political members of the PCSP to carry out both the shortlisting and interview processes to appoint reserve independent members to the partnership.

### 2.0 Background

2.1 Following the local elections in 2023, the NI Policing Board (NIPB) commenced a process to appoint Independent Members to the PCSPs in 2024, to be in place by April of that year.

The appointment process was successful in appointing the requisite number of Independent Members; however, the process has not provided sufficient availability of reserve Independent Members.

2.2 NIPB has completed Stage One of the recruitment process; publicity and engagement activity and the application process. Since the change of political members in Causeway Coast and Glens PCSP, appointment is required of:

Two reserve panel members and appointment of one current panel member to assume the role of panel Chair.

- 2.3 Stage Two of the process will run from November 2024.
- 2.4 The third and final stage of the process is due to commence in Jan/Feb 2025 when Policing Board Member panels will convene to appoint reserve Independent Members to the PCSP. NIPB have contracted the services of a Human Resources (HR) Service Provider to provide support to Councils for Stage 2, who will work closely with each Council HR department to ensure a timely and efficient shortlisting and interview stage.

### 3.0 Proposals

- 3.1 In order to progress Stage 2 of the process, Council have been asked to nominate reserve panel members comprising of up to two political members of the PCSP and identify one current panel member to assume the role of panel Chair.
- 3.2 The nominees will be required to carry out both the shortlisting and interview processes in this stage.
- 3.3 In nominating panel members, Council have been asked to consider balance inrelation to community background and gender.

### 4.0 <u>Recommendation(s)</u>

**It is recommended** that Council approves the move of the current reserve panel member to the full panel, and recommends nominating up two reserve panel members who, where possible, should also be PCSP political members to facilitate a replacement if required.

That in nominating reserve panel members, Council consider balance in relation to community background and gender as per the request from the Northern Ireland Policing Board.

That Council also nominate one current panel member to assume the role of panel Chair.
