**RE: NI Active Travel Delivery Plan - SEA Scoping Consultation**

Further to your e-mail to Shared Environmental Services (SES) on 20<sup>th</sup> May 2024 regarding the above, the e-mail has been circulated to all eleven councils for comment, with particular emphasis on the information (relating to local councils) contained at Appendix A of the report.

On behalf of Causeway Coast and Glens Borough Council (CC&G) Planning Department I wish to comment on Appendix A as follows:

Page	Comment
37	Remove text (in all three columns) relating to the ‘Northern Area Plan (NAP) 2016’ as it is incorrectly placed under the “NATIONAL” section. NAP is a local Plan and referenced under the “LOCAL – CAUSEWAY COAST AND GLENS BOROUGH COUNCIL” section.
66 & 67	<p>NAP is referenced on page 66 and again on page 67. Both sets of text should be merged into one reference and read as follows:</p> <p>“The Northern Area Plan 2016 is the current development plan covering the Causeway Coast and Glens Borough Council area (which contains the four legacy council areas of Ballymoney, Coleraine, Limavady and Moyle). NAP was prepared under the provisions of Part III of the Planning (Northern Ireland) Order 1991, by the Department of the Environment (DOE). It was formally adopted by the Department for Infrastructure (DfI) (formerly DOE) on 22nd September 2015.</p> <p>NAP supersedes the previous statutory plans covering the Borough, as follows:</p> <ul style="list-style-type: none"> <li>▪ Limavady Area Plan 1984-1999</li> <li>▪ Limavady Area Plan 1984-1999 – Alteration No.1</li> </ul>
