3. IN ACCORDANCE WITH STANDING ORDER 3 (1) THE MAYOR HAS CALLED A SPECIAL MEETING OF COUNCIL IN CONSIDERATION OF LEGAL ADVICE RECEIVED IN RELATION TO THE RECOMMENDATIONS FROM THE REPORT FROM NI PUBLIC SERVICES OMBUDSMAN IN RELATION TO A COMPLAINT FROM A MEMBER OF THE PUBLIC

Confidential report, by virtue of paragraph 3 of Part 1 of Schedule 6 of the Local Government Act (Northern Ireland) and appendix was circulated in hard copy and presented by the Director of Environmental Services.

Purpose of the report

The purpose of the report is to allow Council's consideration of the legal opinions and advice received following the approval of the recommendations of the investigation report from NI Public Services Ombudsman (NIPSO) in relation to a complaint from a Member of the Public.

Recommendation(s)

It is recommended that Council considers the legal opinion and advice presented and:

Following consideration of the legal opinion and advice at Appendices 1 and 2 of the confidential report presented at the Special Council Meeting held on 23rd September 2024 re-visit the decision passed at the Council meeting on 6 October 2020 and reconsidered on 1 December 2020¹.

Following consideration of the legal opinion and advice presented accept the legal advice as detailed at Appendices 1 and 2 of the confidential report presented and circulated to Council at the Special Council Meeting held on 23rd September 2024 and take no further action.

The Director of Environmental Services clarified Party Group meetings had been held and the papers made available to all Elected Members in advance of the meeting. He advised K Morgan was in attendance to answer any queries Elected Members may have had.

Councillor Peacock referred to the Legal Opinion stating that subsequent reports had now superseded this report, she proposed Option 2 (4.1.2) with an amendment to the last line. Alderman Boyle seconded Councillor Peacock's motion, also referring to the Legal Opinion, she considered the Scrutiny and Challenge training held had been important and provided advice to new Councillors in light of this.

Councillor Holmes sought clarification of the motion, with a view to closing the matter.

During the course of consideration, Legal Opinion was sought from the representative in attendance.

K Morgan addressed Council and provided advice in relation to the motion.

Councillor Storey stated dissatisfaction with what he stated were clandestine receipt of reports, that for Council to take a decision on a Legal document was not acceptable in terms of proper debate. Councillor Storey stated Council should still be asking who the member of the public was and who was the public representative? He queried whether the Department had been kept informed.

The Director of Environmental Services clarified he would be reporting to NIPSO (Northern Ireland Public Services Ombudsman Office) on the decision of Council, and not the Department.

In response to requests for clarification around the wording from Councillor Wilson, and during the course of consideration, Councillor Peacock varied her motion, with the agreement of Alderman Boyle.

Councillor Wilson requested a Recorded Vote.

The Director of Environmental Services summarised the motion from Councillor Peacock, seconded by Alderman Boyle:
